COUNT I

Between January 1, 2024, and March 31, 2024, Catherine Elizabeth Grimes did knowingly acquire possession of a controlled substance, that is: Lorazepam, classified in Schedule IV of the Indiana Uniform Controlled Substances Act, by misrepresentation, fraud, forgery, deception or subterfuge;

COUNT II

Between January 1, 2024, and March 31, 2024, Catherine Elizabeth Grimes did knowingly acquire

possession of a controlled substance, that is: Tramadol, classified in Schedule IV of the Indiana Uniform Controlled Substances Act, by misrepresentation, fraud, forgery, deception or subterfuge;

COUNT III

Between January 1, 2024, and March 31, 2024, Catherine Elizabeth Grimes did knowingly acquire possession of a controlled substance, that is: Phenobarbital, classified in Schedule IV of the Indiana Uniform Controlled Substances Act, by misrepresentation, fraud, forgery, deception or subterfuge;

COUNT IV

Between January 1, 2024, and March 31, 2024, Catherine Elizabeth Grimes did knowingly acquire possession of a controlled substance, that is: Buprenorphine, classified in Schedule III of the Indiana Uniform Controlled Substances Act, by misrepresentation, fraud, forgery, deception or subterfuge;

COUNT V

Between January 1, 2024, and March 31, 2024, Catherine Elizabeth Grimes did knowingly acquire possession of a controlled substance, that is: Diazepam, classified in Schedule IV of the Indiana Uniform Controlled Substances Act, by misrepresentation, fraud, forgery, deception or subterfuge;

COUNT VI

Between January 1, 2024, and March 31, 2024, Catherine Elizabeth Grimes did recklessly, knowingly or intentionally fail to make, keep or furnish a record or information as required to be kept or filed by I.C. 35-48;

all of which is contrary to statute and against the peace and dignity of the State of Indiana.
