**LIZ MURRILL, ATTORNEY GENERAL** for the State of Louisiana, charges that, on or about the dates listed below, in the Parish of Tangipahoa, State of Louisiana, **ALEXIS NICOLE GEORGE**, defendant herein, knowingly and willfully committed the misdemeanor offenses of ONE (1) count of Abuse of Persons with Infirmities through Electronic Means, and ONE (1) count of Abuse and Neglect of Adults, to wit:


COUNT ONE: On or about June 22, 2023, **ALEXIS NICOLE GEORGE**, defendant herein, did violate: R.S. 14:283.3, Abuse of Persons with Infirmities through Electronic Means, by transferring an image that was obtained by any camera, videotape, photo-optical, photo-electric, unmanned aircraft system, or any other image recording device that was obtained for the purpose of observing, viewing, photographing, filming, or videotaping M.Y. (DOB 6/13/1978), a person with an infirmity, transferring the image by live or recorded telephone message, electronic mail, the internet, or a commercial online service, and transferring the image with the malicious and willful intent to embarrass, shame, harass, coerce,

abuse, torment, or intimidate, regardless of whether the victim has knowledge of the transfer;

COUNT TWO: On or about June 22, 2023, **ALEXIS NICOLE GEORGE**, defendant herein, did violate: R.S. 14:403.2, Abuse and Neglect of Adults, by knowingly and willfully failing to report the abuse and neglect of M.Y. (DOB 6/13/1978), when she was required to report pursuant to La. R.S. 15:1504(A).

*Contrary to the law of the State of Louisiana and against the peace and dignity of the same.*
