The Jurors of the Special Grand Jury of the State of Ohio, duly selected, impaneled, sworn, and charged to inquire of crimes and offenses committed within the body of Franklin County, in the State of Ohio, in the name of and by the authority of the State of Ohio, upon their oath do find and present that:

**COUNT ONE - RACHELLE MONDAY**

**MEDICAID FRAUD**

From on or about November 6, 2021 to on or about May 3, 2023, in Franklin County, Ohio, as a continuing course of criminal conduct, Rachelle Monday did knowingly make or cause to be made a false or misleading statement or representation for use in obtaining reimbursement from the medicaid program and the value of property, services, or funds obtained in violation of this section was seven thousand five hundred dollars or more and was less than one hundred fifty thousand dollars, in violation of Ohio Revised Code §2913.40(B), 2913.40(E), Medicaid Fraud, a Felony of the Fourth Degree.

**COUNT TWO - RACHELLE MONDAY**

**GRAND THEFT**

From on or about November 6, 2021 to on or about May 3, 2023, in Franklin County, Ohio, as a continuing course of criminal conduct, Rachelle Monday did with purpose to deprive the owner, Medicaid program, of property or services, to wit: moneys, knowingly obtain or exert control over either the property or services by deception, and the property or services stolen is valued at seven thousand five hundred dollars or more and less than one hundred fifty thousand dollars, in violation of Ohio Revised Code §2913.02(A)(3), 2913.02(B)(2), Grand Theft, a Felony of the Fourth Degree.

Contrary to the statute in such case made and provided and against the peace and dignity of the State of Ohio.
