INDICTMENT

The Grand Jurors for the State of Maryland for the body of Baltimore County, Maryland do upon their oaths and affirmations charge:

COUNT ONE

(Defrauding a State Health Plan)

Beginning on or about August 10, 2021 and continuing through December 30, 2023, in Baltimore County, Maryland and elsewhere, pursuant to one scheme and continuous course of conduct, **ROTIMI FAGBEMI**, did knowingly and willfully defraud a State Health Plan, to wit: the Maryland Medical Assistance program (Medicaid), which is a State Medical Assistance Plan established in accordance with Title XIX of the federal Social Security Act of 1939, in connection with the delivery of and payment for health care services, having a value of \$1,500 or more in the aggregate, in violation of the Annotated Code of Maryland, Criminal Law Article § 8-509 (1), and against the peace, government, and dignity of the State.

COUNT TWO

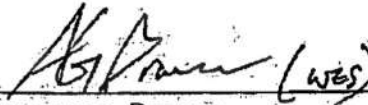
(Felony Theft)

Beginning on or about August 10, 2021 and continuing through December 30, 2023, in Baltimore County, Maryland and elsewhere, pursuant to one scheme and continuous course of conduct, **ROTIMI FAGBEMI** did knowingly and willfully steal money having a value of \$100,000, or more in the aggregate from the Maryland Medical Assistance Program (Medicaid) in violation of the Annotated Code of Maryland, Criminal Law Article § 7-104, and against the peace, government, and dignity of the State.
