MEDICAID FRAUD (1 COUNT)

Section 4-13-213, Miss. Code of 1972, as amended

The GRAND JURORS of the State of Mississippi, taken from the body of the good and lawful citizens of Madison County, Mississippi, being duly selected, impaneled, sworn and charged in the Circuit Court of Madison County, Mississippi, Circuit Court District #20, upon their oaths, present that:

ISLUV ROBERTSON

COUNT I

in Madison County, Mississippi and elsewhere, within a period of time from on or about June 1, 2019 through on or about June 30, 2022, having devised or intending to devise any scheme or artifice to defraud, or for obtaining money, property, or services, or for securing business or personal advantage by means of false or fraudulent pretenses, representations, or promises, or to sell, dispose of, loan, exchange, alter, give away, distribute, supply, or furnish or procure for unlawful use any counterfeit or spurious coin, obligation, security or other article, or anything represented to be or imitated or held out to be such counterfeit or spurious article, for the purpose of executing such scheme or artifice or attempting so to do, transmits or causes to be transmitted by mail, telephone, newspaper, radio, television, wire, electromagnetic waves, microwaves, or other means of communication or by person, any writings, signs, signals, pictures, sounds, data, or other matter across county or state jurisdictional lines, to wit: Isluv Robertson, d/ba/ Sam's Choice Healthcare, having devised a scheme to defraud, or to obtain money by means of false or fraudulent pretenses, representations or promises, submitted false or fraudulent claims for payment to the Mississippi Division of Medicaid, being transmitted electronically or by other means of communication across county or state jurisdictional lines, in direct violation of § 97-19-83(1) of the *Mississippi Code of 1972, Annotated*, as amended, contrary to the statute in such cases made and provided, and against the peace and dignity of the State of Mississippi.

COUNT II

Based on a series of acts connected together and constituting parts of a common scheme or plan, in Madison County, Mississippi and elsewhere, within a period of time from June 1, 2019 through on or about June 30, 2022, did willfully, unlawfully, and feloniously make, present, and cause to be made and presented false, fictitious, or fraudulent claims for Medicaid benefits for service dates and times, knowing the claims to be false, fictitious, or fraudulent, in that Isluv Robertson, d/b/a Sam's Choice Healthcare, submitted materially false and fraudulent claims to the Mississippi Division of Medicaid, which were impermissible per the regulations and practices of the Division of Medicaid, in violation of § 43-13-213 of the *Mississippi Code of 1972, Annotated*, as amended, contrary to the statute in such cases made and provided, and against the peace and dignity of the State of Mississippi.
