On this 18th day of June, 2026, come now, Susan M. Napolitano and Justin J. Hall, Special Deputy County Attorneys and Assistant Attorneys General of the State of Nebraska, who prosecute in the name and by the authority of the State of Nebraska, and hereby amend the Information to support the Amended Complaint against Defendant in the County and State aforesaid, to include the offenses listed herein which Defendant did commit, all contrary to the form of the Statutes in such cases made and provided, and against the peace and dignity of the State of Nebraska, as follows:

1. **THEFT BY UNLAWFUL TAKING, \$5,000 OR MORE** on or about June 30, 2025 through October 15, 2025, inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to A.A. with the intent to deprive them thereof, to wit: money, valued at \$5,000 or more (\$5,150.83);
2. **THEFT BY UNLAWFUL TAKING, \$5,000 OR MORE** on or about August 11, 2023 through September 9, 2025, inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to D.S. with the intent to deprive them thereof, to wit: money, valued at \$5,000 or more (\$54,424.24);
3. **THEFT BY UNLAWFUL TAKING, \$5,000 OR MORE** on or about February 16, 2024 through February 26, 2025, inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to D.S. with the intent to deprive them thereof, to wit: money, valued at \$5,000 or more (\$16,795.77);

4. **THEFT BY UNLAWFUL TAKING, \$5,000 OR MORE** on or about August 10, 2023 to February 27, 2025, inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to J.M. with the intent to deprive them thereof, to wit: money, valued at \$5,000 or more (\$5,251.78);
5. **THEFT BY UNLAWFUL TAKING, \$5,000 OR MORE** on or about April 17, 2023 through October 2, 2025, inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to J.O. with the intent to deprive them thereof, to wit: money, valued at \$5,000 or more (\$8,738.63);
6. **THEFT BY UNLAWFUL TAKING, \$5,000 OR MORE** on or about December 27, 2022 through September 24, 2025, inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to M.T. with the intent to deprive them thereof, to wit: money, valued at \$5,000 or more (\$6,914.98);
7. **THEFT BY UNLAWFUL TAKING, \$5,000 OR MORE** on or about March 4, 2025 through September 15, 2025, inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to M.M. with the intent to deprive them thereof, to wit: money, valued at \$5,000 or more (\$5,893.92);
8. **THEFT BY UNLAWFUL TAKING, \$5,000 OR MORE** on or about May 12 through August 27, 2025 inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to P.B. with the intent to deprive them thereof, to wit: money, valued at \$5,000 or more (\$9,200.00);
9. **THEFT BY UNLAWFUL TAKING, \$5,000 OR MORE** on or about December 14, 2022 through September 5, 2025, inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to R.C. with the intent to deprive them thereof, to wit: money, valued at \$5,000 or more (\$9,261.59);
10. **THEFT BY UNLAWFUL TAKING, UNDER \$5,000 AND MORE THAN \$1,500** on or about May 4, 2023 through October 7, 2025, inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to A.B. with the intent to deprive them thereof, to wit: money, valued at under \$5,000 but more than \$1,500 (\$3,306.92);

- 11. THEFT BY UNLAWFUL TAKING, UNDER \$5,000 AND MORE THAN \$1,500** on or about April 23, 2024 through October 2, 2025, inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to J.W. with the intent to deprive them thereof, to wit: money, valued at under \$5,000 but more than \$1,500 (\$3,633.00);

THEFT BY UNLAWFUL TAKING, UNDER \$5,000 AND MORE THAN \$1,500** on or about December 29, 2022 through October 27, 2025, inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to T.J. with the intent to deprive them thereof, to wit: money, valued at under \$5,000 but more than \$1,500 (\$3,335.35);

THEFT BY UNLAWFUL TAKING, UNDER \$5,000 AND MORE THAN \$1,500** on or about December 13, 2023 through September 5, 2025, inclusive, Becky Stamp did unlawfully, knowingly or intentionally take, or exercise control over property belonging to P.T. with the intent to deprive them thereof, to wit: money, valued at under \$5,000 but more than \$1,500 (\$3,280.15);

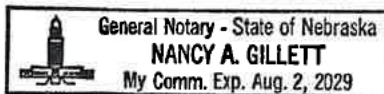
