In the Court of Common Pleas, Franklin County, Ohio, of the Special Grand Jury term beginning February 10, 2026.

The Jurors of the Special Grand Jury of the State of Ohio, duly selected, impaneled, sworn, and charged to inquire of crimes and offenses committed within the body of Franklin County, in the State of Ohio, in the name of and by the authority of the State of Ohio, upon their oath do find and present that:

COUNT ONE - DR. TIFFANY BELL
AGGRAVATED THEFT

From on or about December 27, 2024 to on or about December 11, 2025, in Franklin County, Ohio, as a continuing course of criminal conduct, Dr. Tiffany Bell did with purpose to deprive the owner, The Ohio Department of Medicaid, of property or services, to wit: monies, knowingly obtain or exert control over either the property or services by deception, and the property or services stolen is valued at one hundred fifty thousand dollars or more and less than seven hundred fifty thousand dollars, in violation of Ohio Revised Code §2913.02(A)(3), 2913.02(B)(2), Aggravated Theft, a Felony of the Third Degree.

COUNT TWO - DR. TIFFANY BELL
MEDICAID FRAUD

From on or about December 27, 2024 to on or about December 11, 2025, in Franklin County, Ohio, as a continuing course of criminal conduct, Dr. Tiffany Bell did knowingly make or cause to be made a false or misleading statement or representation for use in obtaining reimbursement from the medicaid program and the value of the property, services, or funds obtained in violation of this section was one hundred fifty thousand dollars or more, in violation of Ohio Revised Code §2913.40(B), 2913.40(E), Medicaid Fraud, a Felony of the Third Degree.

Contrary to the statute in such case made and provided and against the peace and dignity of the State of Ohio.
