The above-named defendant is accused by this information of the crimes of

- Count 1: Theft in the First Degree (FSG=3; C Felony; ORS 164.055)
- Count 2: Theft in the First Degree (FSG=3; C Felony; ORS 164.055)
- Count 3: Forgery in the Second Degree (A Misdemeanor; ORS 165.007)
- Count 4: Forgery in the Second Degree (A Misdemeanor; ORS 165.007)
- Count 5: Identity Theft (FSG=2; C Felony; ORS 165.800)
- Count 6: Identity Theft (FSG=2; C Felony; ORS 165.800)
- Count 7: Computer Crime (FSG=2; C Felony; ORS 164.377)

COUNT 1

The Defendant, on or about April 8, 2025, in Washington County, Oregon, did unlawfully and intentionally commit theft of money, the total value of \$1,000 or more, the property of the Department of Human Services.

COUNT 2

As part of the same act and transaction and part of crimes that are of the same or similar character and a common scheme and plan as Count 1: The Defendant, on or about May 13, 2025, in Washington County, Oregon, did unlawfully and intentionally commit theft of money, the total value of \$1,000 or more, the property of the Department of Human Services.

COUNT 3

As part of the same act and transaction and part of crimes that are of the same or similar character and a common scheme and plan as Counts 1-2: The Defendant, on or about November 1, 2024, in Washington County, Oregon, did unlawfully and with intent to injure or defraud a person, falsely make, complete, or alter a written instrument.

COUNT 4

As part of the same act and transaction and part of crimes that are of the same or similar character and a common scheme and plan as Counts 1-3: The Defendant, on or about March 28, 2025, in Washington County, Oregon, did unlawfully and with intent to injure or defraud a person, falsely make, complete, or alter a written instrument.

COUNT 5

As part of the same act and transaction and part of crimes that are of the same or similar character and a common scheme and plan as Counts 1-4: The Defendant, on or about March 28, 2025, in Washington County, Oregon, did unlawfully and with intent to deceive and defraud, obtain, possess, transfer, create, utter and convert to defendant's own use personal identification of Renae Brown.

COUNT 6

As part of the same act and transaction and part of crimes that are of the same or similar character and a common scheme and plan as Counts 1-5: The Defendant, on or about March 28, 2025, in Washington County, Oregon, did unlawfully and with intent to deceive and defraud, obtain, possess, transfer, create, utter and convert to defendant's own use personal identification of Vanessa Carabjal.

COUNT 7

As part of the same act and transaction and part of crimes that are of the same or similar character and a common scheme and plan as Counts 1-6: The Defendant, on or about March 28, 2025, in Washington County, Oregon, did unlawfully and knowingly access, use a computer, computer system, and computer network for the purpose of devising a scheme or artifice to defraud through which defendant obtained money by means of false and fraudulent representations.

Contrary to the statutes and against the peace and dignity of the State of Oregon.

It is hereby affirmatively declared for the record, upon appearance of the defendant for arraignment, and before the Court asks how the defendant pleads to the charges, that the State intends that any misdemeanor offenses charged herein each proceed as a misdemeanor.
