I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:

That on or about January 16, 2024, through May 12, 2025, the Defendant, Amanda Makins, did knowingly and willfully make unlawful, unauthorized, or improper use of the funds or assets of a vulnerable adult, specifically the victim, D.F., for the profit or advantage of the Defendant. More specifically, the Defendant did utilize funds from the victim's First Citizens bank account for her own personal use, while acting as the victim's Power of Attorney. At all the times relevant, the victim was a resident at Southpointe Healthcare and Rehabilitation, 35 Southpointe Dr., Greenville, SC, within Greenville County, and thus met the definition of a "Vulnerable Adult" under SC Code of Laws, 43-35-0010. The defendant admitted to Investigators that she used the victim's funds for her own personal use. This offense is in violation of 43-35-0085(D) of the South Carolina Code of Laws, 1976, as amended. Affiant and others are witness to prove the same.

I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:

That on or about January 16, 2024, through May 12, 2025, the Defendant, Amanda Makins, did while the victim, D.F., was a resident at Southpointe Healthcare and Rehabilitation, 35 Southpointe Dr., Greenville, SC, within Greenville County, commit the crime of Breach of Trust with Fraudulent Intent. That the Defendant, as the victim's Power of Attorney, was entrusted with the funds or assets of the victim, and that the Defendant, with fraudulent intent, did convert the victim's funds or assets to her own for the profit or advantage of the Defendant. More specifically, the Defendant did Cash App herself funds from the victim's First Citizens Bank Account and make payments towards her own vehicle utilizing the victim's funds. The defendant admitted to Investigators that she used the victim's funds for her own personal use. That the value of the funds or assets converted by the Defendant was approximately \$16,555.36.
