I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:

That on or about November 24, 2024, through August 15, 2025, the Defendant, Belinda Skinner, did, in Colleton County, knowingly and willfully make or cause to be made false claims for payment to the South Carolina Department of Health and Human Services, the state agency that administers the state's Medicaid Program. More specifically, the Defendant, as a Personal Care Services Provider, employed by Akulisny, LLC, did submit false time sheets indicating she had rendered services to victim H.M., when she in fact had not rendered such care. Affiant has obtained and reviewed records that prove the services claimed by the Defendant were not actually rendered. As a result, the Defendant caused false claims for payment to be submitted to the South Carolina Department of Health and Human Services. This offense is in violation of 43-07-0060 of the South Carolina Code of Laws, 1976, as amended. Affiant and others are witness to prove the same.

Breunig** who being duly sworn deposes and says that defendant **Belinda Skinner** did within this county and state on or about November 24, 2024, through August 15, 2025, violate the criminal laws of the State of South Carolina (or ordinance of ☒ County/ ☐ Municipality of: **Colleton**)

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on or about November 24, 2024, through August 15, 2025, the Defendant, Belinda Skinner, did, in Colleton County, commit the crime of Obtaining signature or property by false pretenses, value greater than \$10,000 in that the Defendant knowingly and willfully, by false pretenses or representation, and with the intent to cheat or defraud the South Carolina Department of Health and Human Services (SCDHHS), obtain funds by submitting false claims for payment to SCDHHS, the state agency that administers the state's Medicaid program. More specifically, the Defendant, as a Personal Care Services Provider, employed by Akulisny, LLC, did submit false time sheets indicating she had rendered services to victim H.M., when she in fact had not rendered such care. As a result, SCDHHS received and paid false claims for a total of approximately \$14,572.50. Affiant has obtained and reviewed records that prove the defendant created and submitted fraudulent documents for services claimed by the Defendant which were not rendered as claimed. This offense is in violation of 16-13-240(1) of the South Carolina Code of Laws, 1976, as amended. Affiant and others are witness to prove the same..
