

**ADDENDUM AND EXTENSION OF
SETTLEMENT AGREEMENT BETWEEN
THE UNITED STATES OF AMERICA
AND
THE CITY OF HUDSON, NEW YORK
UNDER THE AMERICANS WITH DISABILITIES ACT
DJ 204-50-281**

1. On October 23, 2019, the United States Department of Justice (Department) and the City of Hudson New York entered into a Settlement Agreement (Agreement) under title II of the Americans with Disabilities Act of 1990 (ADA), 42 U.S.C. §§ 12131-12134, and the implementing regulation, 28 C.F.R. Part 35.
2. This Addendum and Extension (Addendum) serves to extend that Agreement by two years from the original term, until October 23, 2024. The City sought this Addendum pursuant to paragraph 34 of the Agreement which allowed an extension due to substantial and unexpected circumstances. This Addendum is necessary due to delays in progress caused by the COVID-19 pandemic.
3. As of the Effective Date of this Addendum the City of Hudson has fulfilled some of the Agreement's terms, but it has not yet completed certain remedial work required by the ADA and the original Agreement, including but not limited to Curb Ramps and Sidewalks, and City hall.

4. The City Agrees to take immediate action to fulfill its obligations under the original Agreement and the requirements of the ADA, including:
 - a) By no later than December 31, 2022 the Hudson Common Council will pass legislation to enable it to complete its obligations in the Agreement with respect to Curb Ramps and Sidewalks, which will include the creation of a Sidewalk Improvement District.
 - b) If necessary, by no later than February 28, 2023 the City will pass a bond resolution to fund its Sidewalk Improvement District.
 - c) By no later than December 31, 2022 the City will draft and finalize a Request for Proposals (RFP) for the Curb Ramp and Sidewalk construction covered by the original Agreement and this Addendum.
 - d) By no later than December 1, 2022 the City will seek bids on its final construction plans for accessibility upgrades to City Hall and will commence construction as soon as possible thereafter.
5. On bi-monthly anniversaries of the Effective Date of this Addendum until it expires, the City will submit written reports to the Department summarizing the actions it has taken pursuant to the Agreement and this Addendum and will include ILA certifications of all completed work in its reports.
6. Unless otherwise provided herein, the Agreement shall extend throughout the term of this Addendum.
7. The person signing for Hudson represents that he or she is authorized to bind Hudson to this Agreement.
8. The effective date of this Agreement is the date of the last signature below.
