COUNT ONE

The SPECIAL NOVEMBER 2022 GRAND JURY charges:

On or about October 31, 2022, at Lansing, in the Northern District of Illinois,  
Eastern Division, and elsewhere,

CORRIE SINGLETON and  
DARRELL SINGLETON,

defendants herein, did obstruct, delay, and affect "commerce," as defined in Title 18,  
United States Code, Section 1951(b), and the movement of articles and commodities  
in commerce, by robbery, in that the defendants did unlawfully take and obtain a  
quantity of United States currency from the person and in the presence of Brink's  
Courier A, against her will, by means of actual and threatened force, and fear of injury  
to Brink's Courier A;

In violation of Title 18, United States Code, Sections 1951(a) and 2.

**COUNT TWO**

The SPECIAL NOVEMBER 2022 GRAND JURY further charges:

On or about October 31, 2022, at Lansing, in the Northern District of Illinois,  
Eastern Division,

CORRIE SINGLETON and  
DARRELL SINGLETON,

defendants herein, did take and carry away, with the intent to steal and purloin, money exceeding \$1,000 in value belonging to, and in the care, custody, control, management, and possession of Bank A, namely, approximately \$121,824 of United States currency stored in the Bank A ATM located at 16767 Torrence Avenue, Lansing, Illinois, the deposits of which were then insured by the Federal Deposit Insurance Corporation, and in committing such offense, did assault a person, namely Brink's Courier A, by the use of a dangerous weapon or device, namely, a firearm;

In violation of Title 18, United States Code, Sections 2113(b) and (d) and 2.

**COUNT THREE**

The SPECIAL NOVEMBER 2022 GRAND JURY further charges:

On or about October 31, 2022, at Lansing, in the Northern District of Illinois,  
Eastern Division,

**CORRIE SINGLETON,**

In violation of Title 18, United States Code, Section 924(c)(1)(A)(ii).

defendant herein, did knowingly use, carry, and brandish a firearm during and in relation to a crime of violence for which he may be prosecuted in a court of the United States, namely, Hobbs Act robbery, in violation of Title 18, United States Code, Section 1951(a), as further set forth in Count 1 of this Indictment;

In violation of Title 18, United States Code, Section 924(c)(1)(A)(ii).

**COUNT FIVE**

On or about October 31, 2022, at Lansing, in the Northern District of Illinois,  
Eastern Division,

**CORRIE SINGLETON,**

defendant herein, did knowingly use, carry, and brandish a firearm during and in relation to a crime of violence for which he may be prosecuted in a court of the United States, namely, bank larceny by assault, in violation of Title 18, United States Code, Section 2113(b) and (d), as further set forth in Count 2 of this Indictment;

In violation of Title 18, United States Code, Section 924(c)(1)(A)(ii).

**COUNT SIX**

The SPECIAL NOVEMBER 2022 GRAND JURY further charges:

On or about October 31, 2022, at Lansing, in the Northern District of Illinois,  
Eastern Division,

**DARRELL SINGLETON,**

defendant herein, did knowingly use, carry, and brandish a firearm during and in relation to a crime of violence for which he may be prosecuted in a court of the United States, namely, bank larceny by assault, in violation of Title 18, United States Code, Section 2113(b) and (d), as further set forth in Count 2 of this Indictment;

In violation of Title 18, United States Code, Section 924(c)(1)(A)(ii).

**FORFEITURE ALLEGATION**

The SPECIAL NOVEMBER 2022 GRAND JURY further alleges:

1. Upon conviction of an offense in violation of Title 18, United States Code, Sections 1951(a), 2113(b) and (d), and/or 922(c)(1)(A)(ii), as alleged in the foregoing Indictment,

CORRIE SINGLETON and  
DARRELL SINGLETON,

defendants herein, shall forfeit to the United States, pursuant to Title 18, United States Code, Section 924(d)(1) and 981(a)(1)(C), and Title 28, United States Code, Section 2461(c), any and all right, title, and interest they may have in any property involved in the charged offense.

1. The property to be forfeited includes, but is not limited to:
  - a. \$1,025,956 in United States currency recovered during a search of the White Dodge Charger on October 31, 2022;
  - b. a .45 caliber Glock 37, bearing serial number RUP896, and associated ammunition;
  - c. a 9mm Glock 17, bearing serial number BNYA189, and associated ammunition; and

d. a .40 caliber Glock 22, bearing serial number KSP260, and associated ammunition.
