Yesterday, we charged <u>44</u> people with crimes stemming from protest-related violence. We no papered charges against just <u>17</u> arrestees, primarily because no officer could identify what those individuals did wrong. This is not surprising given the hectic nature of Sunday night for police, and the fact that the arresting officer wasn't necessarily the one who saw the alleged wrongdoing, and much of the police paperwork was generic, not AND individualized to the specific person arrested.

Unfortunately, some news media outlets have misleadingly reported that we aren't prosecuting rioting cases. That is plain wrong.

First, we charged the clear majority of defendants presented to us.

Second, the fact we did not charge the generic "rioting" charge does not mean we did not charge defendants for their

particularized criminal wrongdoing. At the complaint stage, we typically only charge the most serious readily provable offense. Additional charges are often added later, as we obtain additional evidence.

Yesterday, the most serious readily provable offense was often felony second-degree burglary, not felony rioting. Burglary has a higher statutory max (15 years v. 10 years), is a defined crime of violence (rioting is not), and perhaps most importantly, **provides a basis under D.C. Code for requesting pretrial detention (rioting does not)**. To all this, burglary has the added advantage of being much easier to prove than rioting.

Where we didn't charge burglary, we still charged the most serious readily provable offense (such as misdemeanor unlawful entry or assault). In such instances, the charge we selected contained the same statutory maximum (180 days) as the most relevant rioting equivalent (the misdemeanor variety, also 180 days max). And unlawful entry or assault have, from experience, the advantage of also being much easier to prove than misdemeanor rioting.

In sum, if we had the evidence to charge someone, we did so. And when we charged, we selected the most serious readily provable offense, which also happened to be the charge with the greatest likelihood of resulting in a conviction.

Hope this finds you well. I am just looking for more information about how and why the decision was made to send various teams from the DOJ into Miami following protests this weekend. The below was sent to me by the BOP, and it lists only Miami and Washington DC as places where these teams were sent:

The BOP has specialized Crisis Management Teams (CMTS), including Special Operations Response Teams, which are highly trained tactical units capable of responding to prison disturbances, and providing assistance to other law enforcement agencies during emergencies. The BOP's CMTs also include Disturbance Control Teams, that specialize in crowd control scenarios.

Per the request of the Attorney General, the BOP has dispatched teams to Miami, Florida, and Washington, D.C.

I am primarily trying to understand why the AG requested a team be sent to Miami, as protests here have been relatively small in scale and peaceful, when compared with other places like New York City, Chicago and Los Angeles.

Also any info about what the team is doing at this time, any coordination with local law enforcement, etc.. would be much appreciated.

Man Who Brandished Assault Rifle at Protest Charged With Making Threats

A man who brandished an assault rifle at a Black Lives Matter protest in Lubbock on Saturday has been charged with making interstate threats, announced U.S. Attorney for the Northern District of Texas Erin Nealy Cox.

According to a criminal complaint unsealed today, Emmanuel Quinones, a 25-year-old local, allegedly brought a loaded Smith & Wesson .223 caliber semi-automatic to a protest decrying the death of George Floyd, a black man who died at the hands of Minneapolis police last month.

In view of the protesters, Mr. Quinones held the rifle at "low ready," in firing position with the muzzle pointed toward the ground, as panic rippled through the assembled crowd. (Although Texas is an open-carry state, the Texas Penal Code makes it illegal to display a firearm in a public place "in a manner calculated to alarm.")

Mr. Quinones allegedly refused a Lubbock Police officer's verbal commands to drop the rifle, and only did so when the officer drew his gun. A protester then tackled Mr. Quinones, who allegedly shouted, "this is a revolution" and "President Trump must die" as he was taken into custody.

During an interview, Mr. Quinones admitted that he previously made social media posts designed to "intimidate" the President and "MAGA instigators." One such post, shared on Facebook on May 28, intimated that he planned to obtain gun parts "to off racists and MAGA people."

In the interview, the defendant stated he attended the protest to protect demonstrators from these so-called MAGA (Make America Great Again) instigators, who he planned to shoot on sight. He claimed the police would not have been able to identify these counter-protestors, but that he could have.

"Instead of respecting citizens' rights to respectfully voice their feelings, this defendant incited panic, putting everyone present – including those he claimed to support – in danger," said U.S. Attorney Erin Nealy Cox. "We will not tolerate attempts to instill terror or encourage violence at otherwise peaceful protests."

"The FBI respects the rights of individuals to peacefully exercise their First Amendment rights. In this case, the defendant threatened multiple lives including the President of the United States and that will not be tolerated," said FBI Dallas Special Agent in Charge Matthew J. DeSarno. "We will continue working with our local, state, and federal partners to apprehend and charge violent instigators who are exploiting legitimate, peaceful protests and engaging in violations of federal law."

A criminal complaint is merely an allegation of unlawful conduct, not evidence. Mr. Quinones is presumed innocent unless and until proven guilty in a court of law

He made his initial appearance Tuesday afternoon before U.S. Magistrate Judge D. Gordon Bryant. If convicted, the defendant could face up to five years in federal

prison.

The Federal Bureau of Investigation Dallas Field Office, Lubbock Resident Agency, the United States Secret Service, the United States Bureau of Alcohol, Tobacco, Firearms, & Explosives, and the Lubbock Police Department conducted the investigation. Assistant U.S. Attorney Jeff Haag is prosecuting the case.



Please be advised that State Dept has drafted the attached statement to be made to the Organization for Security and Cooperation in Europe (OSCE) this coming Thursday addressing the situation in the US. It's acceptable, even makes some strong points in a couple of places. Given the important of the subject-matter OLP wanted to make sure OAG and ODAG had a chance to review. Please let me know by Wed morning if possible if you have any concerns. CRT is also reviewing, but b/c of the timing I wanted to get it directly to you now.

For background--OSCE is a collection of Western European and Soviet-successor states that is supposed to promote democracy and human rights among its members. They do things like monitor elections, issue resolutions, fund democracy-building training programs etc., like a mini-UN for European and

nearby countries. Like other int'l org they seem to take pleasure in criticizing the US, and we may receive such criticism at Thursday's meeting from Russia and some other countries. For reference, here is the statement from the OSCE rep on freedom of the media to which the statement partially responds:

VIENNA, 1 June 2020 – The OSCE Representative on Freedom of the Media, Harlem Désir, expressed his concern today regarding the wave of violence against journalists covering protests across the United States of America in recent days.

"I am deeply concerned by the number of incidents and attacks by police and demonstrators against journalists covering protests in the United States over the past few days," said Representative Désir. "Many of these incidents involved arrests and the use of force by police, including rubber bullets, pepper bullets, tear gas and pepper spray, as well as acts of violence by protesters. I call on the authorities to exercise restraint and to ensure that journalists can work safely while reporting on public protests. The role of a free press must be safeguarded at all times and journalists must be free to report without facing violence, arrest or intimidation."

Protests erupted in Minneapolis on 25 May, following the killing of a black man, George Floyd, and have since spread across the country.

According to media reports, over the past few days, several journalists, who identified themselves as members of the press by wearing armbands, press cards or vests, were injured by police firing rubber bullets, pepper bullets, and tear gas. These included Reuters camera operator Julio-Cesar Chavez and his security advisor (Minneapolis); photographer Hyoung Chang and journalist Elise Schmelzer, both from the Denver Post (Colorado); photojournalist Jan Czernik of Denver 7 News, who also had his camera broken (Denver); reporter Kaitlin Rust and photojournalist James Dobson of WAVE3 News (Louisville); freelance journalist Linda Tirado, who was left permanently blind in one eye (Minneapolis); and Swedish Expressen journalist Nina Svanberg, and Norwegian photographer Thomas Nilsson of Verdens Gang (Minneapolis). Police also fired pepper spray against other journalists, including Molly Hennessy-Fiske, a Los Angeles Times journalist (Minneapolis); Michael Adams, a VICE News journalist (New York City); and RIA Novosti correspondent Mikhail Turgiev (Minneapolis).

Alongside this, police also reportedly arrested or detained several journalists. These included Review-journal photographer Ellen Schmidt, and Bridget Bennett, a freelance journalist on assignment for AFP (Los Angeles); photographer Tom Aviles of WCCO, a local CBS station (Minneapolis); Huffington Post reporter Chris Mathias (New York City); Adam Gray, a New York-based British photojournalist for SWNS (New York City); Amandine Atalaya and Mathieu Derrien from French TV TF1 (Minneapolis); and Tim Arvier and his crew from Nine News Australia (Minneapolis).

A number of incidents involving attacks by protesters against journalists were also recorded. Paul Ahmann of WLKY was knocked over and beaten by protesters, suffering a concussion and having to be taken to hospital (Louisville); Leland Vitter and his crew from Fox News were attacked and chased by protesters (Washington, D.C.); Ian Smith, a photojournalist for KDA TV, was beaten by protesters and had his equipment destroyed (Pittsburgh); and Briana Whitney of CBS was harassed by a protester who pushed her and attempted to grab her microphone (Phoenix).

In addition, several TV crews had their equipment or vehicles damaged. According to reports, protesters threw rocks at a WSB-TV news van (Atlanta), while two vehicles belonging to WLKY News and one belonging to WAVE3 News were also vandalized (Louisville).

The Representative recalled his Office's "Special Report on Handling of the Media during Political Demonstrations: Observations and Recommendations", which states that "law-enforcement officials have a constitutional responsibility not to prevent or obstruct the work of journalists during public demonstrations, and journalists have a right to expect fair and restrained treatment by the police."

Hope this finds you well. I am just looking for more information about how and why the decision was made to send various teams from the DOJ into Miami following protests this weekend. The below was sent to me by the BOP, and it lists only Miami and Washington DC as places where these teams were sent:

The BOP has specialized Crisis Management Teams (CMTS), including Special Operations Response Teams, which are highly trained tactical units capable of responding to prison disturbances, and providing assistance to other law enforcement agencies during emergencies. The BOP's CMTs also include Disturbance Control Teams, that specialize in crowd control scenarios.

Per the request of the Attorney General, the BOP has dispatched teams to Miami, Florida, and Washington, D.C.

I am primarily trying to understand why the AG requested a team be sent to Miami, as protests here have been relatively small in scale and peaceful, when compared with other places like New York City, Chicago and Los Angeles.

Also any info about what the team is doing at this time, any coordination with local law enforcement, etc.. would be much appreciated.





Statement from United States Attorney G. Zachary Terwilliger

ALEXANDRIA, Va. - These have been difficult and challenging times over the past 10 weeks due first to a pervasive pandemic and now as a result of great societal unrest. We witnessed the harrowing and disturbing video images of the death of George Floyd. We watched many peaceful protestors exercise their constitutional rights to protest legitimate grievances. And while it should be a time for the nation to grieve, scream, pray, shake with anger, reconcile, and heal, some have turned violence, to destruction, arson, assault, and domestic terrorism.

Many individuals gathering to protest in the Eastern District have done so peacefully. Unfortunately, there are some individuals who seek to actively undermine the efforts of peaceful protestors by inciting violence and destroying the very physical and figurative sinew of local communities of which they are not members.

Following the decisive leadership of Attorney General Barr, we will utilize the existing framework of the Joint Terrorism Task Force model to identify, apprehend and prosecute anyone who uses the guise of protest to incite violence and violate federal laws.



Barr seeks to squelch D.C. protests by 'flooding the zone' with federal firepower

By Devlin Barrett June 3, 2020 at 6:03 p.m. EDT

From an FBI command center in Washington's Chinatown neighborhood, Attorney General William P. Barr has orchestrated an stunning show of force on the streets of the nation's capital — a battalion of federal agents, troops, and police designed to restore order, but one that critics say carries grim parallels to heavy-handed foreign regimes.

Barr was tapped by President Trump to direct the national response to protests and riots over police misconduct since the police-custody death of George Floyd in Minneapolis.

The attorney general has focused much of his attention on Washington, D.C., where unrest and arrests swelled over the weekend before a jarring clash Monday to clear peaceful protesters from outside the White House — an order Barr issued personally. By Tuesday night, as he sat in the FBI command center until nearly midnight, the city's mood seemed to have calmed.

Barr personally ordered removal of protesters near White House, leading to use of force against largely peaceful crowd

The strategy, said one Justice Department official, is to put "the maximum amount of law enforcement on the street, and people comply just because they are there ... The idea is to flood the zone, that's what we've done, and the city has significantly quieted down."

While large protests Tuesday night included thousands of people breaking the city's curfew, Barr and his advisers reason that as long as such activities are peaceful, they are not going to be challenged by federal enforcers.

"The peacefulness is in large part due to the large law enforcement presence," said the Justice Department official, who like others spoke on the condition of anonymity to describe internal deliberations.

The display of federal might — in D.C. and other restive cities where protests have turned destructive — includes military vehicles at many intersections, helicopters, federal law enforcement agents assigned to patrol and investigate possible crimes, street closures and frequent checkpoints. Troubling to some has been the presence of personnel, some heavily armed, clad in tactical attire bearing no identifiable insignia. On the night he took charge of the effort, Barr walked the streets to see for himself how personnel were deployed.

Some law enforcement experts contend the dramatic scenes are counterproductive in the long run, affirming the very criticism leveled by protesters — that police and government officials treat citizens unjustly.

"The heavy hand is a smack in the face, and the danger is that it may make things worse," said Dennis Kenney, a professor at John Jay College in New York with expertise in police response to protests. "It really does communicate something about where those who are in charge think our society sits right now. We're in the process of demonstrating to the people who are out in the streets that they are right to be there."

Kenney said he was struck by the president's walk Monday to a church near the White House, under a phalanx of armed guards. It reminded him of when he advised a government minister in Yemen that he should use a soft touch on protests. The minister refused and, in six months, could not safely travel anywhere beyond his home and his office.

Police turn aggressive against protesters and bystanders, adding to disorder

The Justice Department official said such criticism was unwarranted.

"What would be the alternative, letting people burn down the city?" the official asked. "The force is necessary to restore order and civility so people can go ahead with their lives because, prior to this, things were really getting out of hand. This only benefits everyone."

Barr has said the government must "dominate" the streets to restore order and put an end to the looting, rioting, and vandalism that has marred Washington, New York, Minneapolis and elsewhere.

From the FBI command center, the attorney general coordinates with the Pentagon and a variety of federal agencies fanned out across the capitol. Tennessee and Florida announced Wednesday they were sending National Guard troops to the city to further beef up those efforts. Barr has also ordered agents with the FBI, Drug Enforcement Administration, U.S. Marshals and the Bureau of Prisons to help protect the city.

Justice Department officials took the sharp drop in arrests Tuesday night as a sign that the strategy is working. While the crowds of protesters were as large or larger than previous nights, there was far less property destruction or violence compared to previous evenings.

A second Justice Department official said Wednesday that there has been "a tremendous amount of restraint" shown by D.C.'s Metropolitan Police Department and the other law enforcement agencies. The official said that so far, none of those arrested have been accused of being part of extremist groups, but investigators are still examining the backgrounds of some and scrutinizing social media posts to for evidence of anyone who may be organizing, orchestrating or encouraging violence amid the protests.

"We can exploit phones, data communications to see if there is a coordinated command and control, that's what we're looking for," the official said.

Cities increasingly turn to curfews to quell protests

A central focus in Barr's effort is steering criminal cases into the federal system, where suspects are likely to face stiffer prison sentences. As part of that push, two Minnesota men were charged Tuesday with firebombing a local court office building.

According to a criminal complaint, Garrett Patrick Ziegler, 24, and Fornandous Cortez Henderson, 32, were charged with arson and possession of molotov cocktails after detectives in Apple Valley, Minn., found a set of car keys near the crime scene that led them to the suspects.

The case was turned over to federal prosecutors and the Bureau of Alcohol, Tobacco, Firearms and Explosives.

As in the Minnesota case, ATF is helping local police departments with arson investigations related to the unrest, while other agents are helping patrol public spaces. Other federal agencies are also taking up cases involving violence or

vandalism related to the protests. So far, about a dozen people have been charged federally in such cases, and scores more are under investigation, according to officials.

In New York, acrimony and finger pointing as NYPD struggles to stop looting and violence

The Drug Enforcement Administration has received special permission to go beyond its standard legal mandate of investigating drug-related crimes to also investigate crimes related to the protests, according to an internal document first reported by BuzzFeed News.

The Justice Department authorization, which lasts for 14 days, allows the DEA to conduct "covert surveillance" and share intelligence with state and local officials, as well as patrol public places and make arrests for non-drug crimes as officials see fit. A DEA spokeswoman declined to comment.

It is unusual for federal agents to engage in such duties, but they have been pressed into service by Barr, who has called the public vandalism and violence surrounding the protests "domestic terrorism."

Some of the federal agents deployed around Washington have been wearing military-style tactical gear with no markings to indicate their names or the agencies for which they work. Six years ago, the Justice Department criticized the Ferguson, Mo., police department for allowing its officers work without wearing nameplates.

"Officers wearing name plates while in uniform is a basic component of transparency and accountability," the Justice Department's civil rights division wrote at the time. "It is a near-universal requirement of sound policing practices. ... Allowing officers to remain anonymous when they interact with the public contributes to mistrust and undermines accountability."

FBI charges Illinois man with rioting, handing out 'bombs' in Minneapolis

Kenney, the policing expert, said federal law enforcement agents are a poor fit for what should be the twin goals of government: using National Guard troops to protect the protesters, and using police in reserve to pursue any lawbreakers.

"What the DEA and all the other federal law enforcement agencies are going to contribute is totally beyond me," said Kenney. "They're of little value and should be cleared out."

Democrats have also criticized Barr's handling of the crisis, particularly the decision to clear Lafayette Square of protesters just before the president's walk to get his photo taken outside a church. On Wednesday, four senior House Democrats wrote to Barr seeking answers about that decision and declaring "the use of federal personnel to prevent American citizens from exercising their Constitutional right to peaceably assemble represents a direct threat to our democracy."

The FBI's Washington Field Office, which holds the command center where Barr oversees the government response, issued a statement saying it "respects the rights of individuals to peacefully exercise their First Amendment rights. We are working actively and closely with our local, state, and federal law enforcement partners and are committed to apprehending violent instigators who are exploiting legitimate, peaceful protests and engaging in violations of federal law."

The attorney general has also instructed the FBI's joint terrorism task forces to assist in the efforts. Officials said agents in the JTTFs have been assigned to gather video and photo evidence of possible lawbreakers, as well as take tips from local police departments about particular suspects or cases. One official, speaking on the condition of anonymity to discuss law enforcement practices, said the JTTFs' work on identifying criminal activity related to the protests does not mean the agency has changed its rules for how it uses surveillance powers toward Americans — the legal limitations around national security intelligence authorities still apply, the official said.


The government's show of force has not been welcome or necessary everywhere. As part of the Justice Department effort, Barr ordered special riot control teams from the Bureau of Prisons to deploy in Washington and Miami, where the situation has been relatively calm. Another law enforcement official said the team had not been needed there and would depart.

How do you want the images displayed in the room? My guess is that unless the display is right next to the AG, it won't make it into pool's shot. Here are some options:

- 1. We use the monitors already installed in the room. This will only be visible to the people in the room. This would need to be set in advance and would need to cycle on a regular schedule (eg, every 10 seconds) or display only one image the entire time.
- 2. There's a giant monitor behind the curtain. This would be in the shot but the background would be wood instead of blue drapes, and would mean the speakers would be awkwardly spaced to either fit 6 people to the sides, or standing in front of the monitor and blocking half/more of the image. Same as above, this would need to be set in advance and would need to cycle on a regular schedule (eg, every 10 seconds) or display only one image the entire time.
- 3. I can see if we can find some monitor that can be rolled into the room and put on stage. I have no idea if this is possible. WASHINGTON – Attorney General William P. Barr has issued the following statement:

"The greatness of our nation comes from our commitment to the rule of law.

The outrage of our national community about what happened to George Floyd in Minneapolis is real and legitimate. Accountability for his death must be addressed, and is being addressed, through the regular process of our criminal

justice system, both at the state and at the federal level. That system is working and moving at exceptional speed. Already initial charges have been filed. That process continues to move forward. Justice will be served.

Unfortunately, with the rioting that is occurring in many of our cities around the country, the voices of peaceful protest are being hijacked by violent radical elements.

Groups of outside radicals and agitators are exploiting the situation to pursue their own separate and violent agenda.

In many places, it appears the violence is planned, organized, and driven by anarchistic and far left extremists, using Antifa-like tactics, many of whom travel from out of state to promote the violence.

We must have law and order on our streets and in our communities, and it is the responsibility of the local and state leadership, in the first instance, to halt this violence. The Department of Justice (including the FBI, Marshals, ATF, and DEA), and all of our 93 U.S. Attorneys across the country, will support these local efforts and take all action necessary to enforce federal law.

In that regard, it is a federal crime to cross state lines or to use interstate facilities to incite or participate in violent rioting. We will enforce these laws."



Now every service chief has denounced racism in the ranks. Shortly after Defense Secretary Mark Esper told reporters Wednesday he sent a memo to department employees about racism, U.S. military leaders of every service branch delivered their own public message about racism in society and within the ranks — and obliquely, about the proper role of armed forces in a country roiled by protest. *Defense One*'s Marcus Weisgerber, Kevin Baron and

Bradley Peniston tracked the reactions and rolled them all up, here.

"Racism is real in America, and we must all do our very best to recognize it, to confront it, and to eradicate it," Esper said Wednesday. And according to his memo to the force, he wrote, "I, like you, am steadfast in my belief that Americans who are frustrated, angry, and seeking to be heard must be ensured that opportunity."

Air Force leaders were the first among their cohort to speak out about George Floyd, who on May 25 became the latest unarmed black man killed by law enforcement officers. Chief Msgt. Kaleth Wright, the Air Force's top enlisted official, tweeted Monday that his "greatest fear" is "that I will wake up to a report that one of our Black Airmen has died at the hands of a white police officer." The following day, Gen. David Goldfein, the Air Force chief of staff, joined Wright in a video posted on the service's social media channels.

Also on Tuesday, U.S. Space Force's commander and top enlisted leader, Gen. John Raymond and Chief Master Sgt. Roger Towberman, released a <u>letter</u> to the force that began, "The tragic death of George Floyd is wrong and goes against the founding principles of our it also serves as a stark reminder that racism and the unequal treatment is a reality for many and a travesty for all."

The Army followed on Wednesday. Then came the Navy. By early evening, the U.S. Marine Corps commandant and Sergeant Major of the Marine Corps had posted and tweeted their statement. "Marines and Sailors, last summer, in my planning guidance, I stated there is no place in our Corps for racists," said the statement issued by Gen. David Berger and Sgt. Maj. Troy Black. "Current events are a stark reminder that it is not enough for us to remove symbols that cause division – rather, we also must strive to eliminate division itself."

Then Wednesday evening, National Guard chief Gen. Joseph Lengyel released his own memo, which <u>reads</u>, in part, "I am enraged that this story...keeps happening in our country, where unarmed men and women of color are the victims of police brutality and extrajudicial violence."

And here's U.S. Coast Guard Commandant Adm. Karl Schultz, speaking to Defense One Radio in a forthcoming exclusive interview:

"I've got a lot of shipmates that are angry, scared, wary; and shipmates who may feel as a nation, we haven't fully availed that American dream of equal opportunity — inalienable rights of life, liberty and happiness at all — among us. So we're focused on just making sure we're vigilant to shortcomings inside our own Coast Guard. We're really focused on inclusive leadership and being good shipmates, keying in on mutual respect — starting with simple questions to our African-American shipmates: How are you doing? Really focused on the art of respectful and empathetic listening."

Thirteen of those spots have no announced nominee, including the full undersecretary of policy" — a role Anderson has filled since John Rood was forced out in February — "and is likely to continue to fill." In a reversal, the Philippines has now decided to keep its military agreement with the U.S. "as territorial tensions with China heat up in the South China Sea," CNN reported Wednesday. "The agreement, signed in 1988, gives US military aircraft and vessels free entry into the Philippines and relaxes visa restrictions for US military personnel. The Philippine government gave the US 180 days' notice to end the deal in February, suggesting that Manila needed to rely on its own resources for its defense. On Tuesday, the US welcomed the change of heart."

As we typically do in cases such as this, the Department of Justice is conducting a parallel and independent investigation into possible violations of federal civil rights laws.

The President has directed me to spare no effort. We are coordinating our work with that of Minnesota Attorney General Keith Ellison. As a matter of comity, the Department of Justice typically lets the State go forward with its proceedings first.

This afternoon, our United States Attorney in Minnesota and FBI Special Agent in Charge of the Minneapolis Field Office will attend a memorial service for Mr. Floyd. Today is a day for mourning, and the day is coming soon when justice will be served.

George Floyd's death was not the first of its kind, and it exposes concerns that reach far beyond this case.

At some demonstrations, there are groups that exploit the opportunity to engage in looting. And finally, at some demonstration, there are extremist agitators who are are hijacking the protests to pursue their own separate and violent agenda.

We have evidence that Antifa and other similar extremist groups, as well as actors of a variety of different political persuasions, have been involved in instigating and participating in the violent activity. We are also seeing foreign actors playing all sides to exacerbate the violence.

The Department of Justice is working to restore order in the District of Columbia and around the Nation. Here in Washington, we are working around the clock with local police, the citizen soldiers of the National Guard, and other federal agencies to provide safety and justice. We have deployed all the major law-enforcement components of the Department in this mission, including the FBI, ATF, DEA, Bureau of Prisons, and U.S. Marshals Service. I thank them and all those working bravely and professionally to protect the District.

The Justice Department is also working closely with our State and local partners to address violent riots around the country. Our Federal law enforcement efforts are focused on the violent instigators.

Through the FBI, U.S. Attorney's Offices, component field offices and state and local law enforcement, we are receiving real-time intelligence, and we have deployed resources to quell outbreaks of violence in several places. I urge governors, mayors, and other state and local leaders to work closely with their National Guards and with us. The federal government has thus far made [51] arrests for federal crimes in connection with violent rioting. We will continue to investigate, make arrests, and prosecute where warranted.

When I was Attorney General in 1992, violent riots broke out in Los Angeles following the acquittal of the police officers accused of beating Rodney King. Ultimately, the Department at my direction filed federal civil rights charges against the officers. As President Bush assured the Nation at that time, "The violence will end. Justice will be served. Hope will return." The same is true today. The rule of law will prevail. Thank you.

When I was Attorney General in 1992, violent riots broke out in Los Angeles following the acquittal of the police officers accused of beating Rodney King. Ultimately, the department at my direction filed federal civil rights charges against the officers. As President Bush assured the Nation at that time, "The violence will end. Justice will be served. Hope will return." The same is true today. The rule of law will prevail. Thank you.

NGRAHAM: All right. I'm Laura Ingraham. This is "The Ingraham Angle" from Washington tonight. For reasons that totally escaped me, the city from which we broadcast has decided to push the curfew from 7:00 pm to 11:00 pm just to make everybody's lives more difficult to we're trying to keep the peace.

We're going to bring you a report in moments about what has happened so far and what has this meant to the situation on the ground. Now, also tonight to former FBI agents who specialize in tracking and analyzing domestic anarchists, tell us what's really happening. What's burrowed in now on American streets beyond the peaceful

protests and the demands for justice.

And Raymond Arroyo is going to bring us a story that has blown up throughout the night. New Orleans quarterback Drew Brees is getting shredded by his peers. Now, what is this crime? He said, and I'm not joking, that he will never disrespect the American flag. That's his crime. Think about how sick of a moment we find ourselves in when that sentiment, by such an amazing person such as Drew Brees, is controversial.

But first two hours into their curfew, the NYPD has begun the crackdown now. Over the past hour they've arrested 60 protesters, and now we're waiting to see what comes next. Let's go live to the streets of New York, where Fox's Bryan Leenas is standing by. Bryan what happened earlier? And what might we expect as the night goes on given your vantage point.

BRYAN LEENAS, FOX NEWS NATIONAL CORRESPONDENT: Laura, good evening. We are on Third Avenue and 50th Street in Midtown East. About, I would say, 40 minutes ago, about hundreds of protesters marching down peacefully were met by the NYPD an hour and a half or so - hour after curfew and it was clear that it was done. The NYPD wanted them off of the streets.

These bikes here with --from the NYPD, they came in on bikes and they started making the rest behind me. You can see, they've got some of these people who have been arrested for curfew violation. We're told at least 60 arrests. We spoke to the chief just a few months ago. This is what he had to say about the situation.

(BEGIN VIDEO CLIP)

CHIEF TERENCE MONAHAN, NEW YORK CITY POLICE DEPARTMENT: From Thursday night, we've been facing rock, bottles, bricks. We've been shot at. We've been run over by cars. But they're still out there, as you can see, in force, keeping the city safe, being extremely effective out there, doing the job. Making sure that the city is our city. We are one with the protesters who are out there for justified cause, but not with the people who want to cause mayhem for our city.

LEENAS: Again, the NYPD, this is the second night of an 8:00 pm curfew. Obviously, they are - really they're making arrests. This is after days of mass looting up and down Midtown Manhattan. They're sending a message that they want people off the streets and we were here when they moved in and made the arrest.

Again, I got to stress peaceful protests, but curfew violations. They believe, Laura, that these people on the streets with protest gives an opportunity for looters and criminals

to do their crimes. That's why they want these streets clear.

INGRAHAM: I would say, Bryan, someone just sent me a video of Fifth Avenue. And I hadn't seen it and I was shocked. I mean, you've been there every night. Every storefront - almost every storefront was hit, and now boarded up. And if they want businesses to come back and employ all the people who are on the streets, and some who might be moving into the city, they have to get business back. And they're in a they're in a real pickle if they don't get business back.

But Bryan, thanks for that report. We're going to keep our eyes on it and keep in touch with us throughout the hour.

LEENAS: Thank you.

INGRAHAM: And now social distancing, from reality. That's the focus of "Tonight's Angle." The left's rules, have you noticed this, they never seem to apply to them. Now, we've seen this play out with Governor Ralph Northam not wearing his mask at the beach or Governor Whitmer's hubby traveling to their family cabin up north or Governor Pritzker's family escaping from Illinois to that awful dangerous State of Florida.

Mayor Lori Lightfoot, she got her hairstyle that she kept salons closed for everyone else in Chicago. But if you still want it to give these blue state governors and mayor's the benefit of the doubt on these COVID lockdowns, well, now you can disabuse yourself of that notion for good. In late April, Mayor de Blasio denounced Hasidic Jews who gathered for a funeral in Brooklyn, and he used the police to break it up

MAYOR BILL DE BLASIO, NEW YORK CITY, NEW YORK: The notion that people would gather in large numbers, and even if they mean to, would spread a disease that will kill other members of the community is just unacceptable to me. If you saw anger, and frustration, you're right. I spoke out of real distress that people's lives were in danger before my eyes and I was not going to tolerate it.

INGRAHAM: People's lives were in danger at the funeral, OK, but when throngs of looters, roamed the streets to smash and grab and push aside or worse, anyone in their way, suddenly there's zero concern for public health, COVID and the police, by de Blasio, are told to use a light touch.

DE BLASIO: Overwhelmingly peaceful protest. Protesters respecting the ground rules set by police. Police doing exactly what they're so good at.

DE BLASIO (via telephone): There's a small anarchist group that's been violent and then there's a small criminal element that's been violent. But you're talking about a incontestable percentage compared to the overwhelming majority of the protesters who have been peaceful

INGRAHAM: No COVID concerns. So - but it's thousands of people show up in, let's say, let's move on to Charlotte, North Carolina to march against police brutality. OK, they're welcomed fine. So you're right to peaceful protests. But if thousands of RNC attendees want to rally in Charlotte, two months from now, they're called the irresponsible, dangerous, selfish.

DON LEMON, CNN HOST: The President's extremely irresponsible bullying and potentially deadly threat today, in the middle of this deadly pandemic, to move the Republican National Convention from Charlotte.

WOLF BLITZER, CNN HOST: He wants, what, 20,000 people to gather. In the arena, they're packed, screaming, shouting on top of each other, right in the midst of this pandemic. Is that what he's saying?

(END VIDEO CLIP)

INGRAHAM: Have any of you seen the crowds in Raleigh and Charlotte, North Carolina? Well, if you want to open your restaurants, doors to customers, they're going to stop you or they're going to send state inspectors, and they're going to have measuring tapes and they're going to make sure that your salad bar is in order. But if you want to ransack a restaurant, they'll give you the green light.

And if you want to go to church, they'll send cops out to harass you. But if you want to burn down the church, they'll basically look the other way or excuse it. If you want to protest the lockdowns at the state capital, you're called a terrorist and a threat to public health and safety. But now, if you're marching in a crowd carrying a sign that says "F" Trump, you're organizing for change. No COVID problems there.

And if you're thinking about, let's say hitting the beach--

(BEGIN VIDEO CLIP)

GOV. GAVIN NEWSOM (D-CA): This virus doesn't take the weekends off. This virus doesn't go home, because it's a beautiful sunny day around our coasts.

(END VIDEO CLIP)

INGRAHAM: But apparently the virus has taken the entire week off, or it's just overall together and they didn't bother telling us. The bottom line is that lockdowns and rules were good when they made your lives inconvenient and took away things that were essential to you.

But suddenly, when the lockdown, their all the rules interfered with achieving their political goals, they no longer mattered, so much for phases 1, 2, 3 and 4, paging Dr. Fauci. Well, this is all political in the end for Democrats, all of it. They want to stop President Trump and his supporters from having rallies or even a convention. Meanwhile, they applaud tens of thousands of people packed tightly into streets and parks to support their own efforts to defeat him. Isn't that a neat trick?

Well, what about these protests? Peaceful protests, we've said this night after night, it's the hallmark of any free society, and we applaud peaceful protests, as we explained for months to left wingers who tried to force us to stay home. But the left, their protests have become essentially right now part of a religion that is essential, so that must be protected.

But it's also become part social club. And the same geniuses who love to mock Baptists are out in the streets with their own rituals. Membership rules, they have punishment for heretics even. And it seemed that look like Jonestown meets pilates, a bunch of rich white liberals gathered in Bethesda, Maryland, suburb of Washington DC, to repeat their almost religious mantras.

INGRAHAM: Now let's be clear. Everyone is infuriated. Anyone with a shred of decency about what happened to George Floyd, everyone wants justice to be done. But those creepy rallies have nothing to do with George Floyd, at least for most of the people on the left. His tragedy is their excuse.

Look, the folks you see yelling at cops on TV, a lot of the wealthy suburban kids, I guess they're tired of sitting home playing video games or buying stuff on Amazon Prime. They're trying to check their privilege while checking their Apple watches.

The left wants everyone on their knees, not in prayer for racial healing or George Floyd, but in submission to their ever growing list of demands. Today, they demand we defund the police.

UNIDENTIFIED MALE: Now, most people don't realize that only 5 percent of the arrest had happened in the country actually happened for violent crime.

We don't need to fund policing in the way that we do. We have to shrink the role of the policing apparatus wholly.

INGRAHAM: Well, tomorrow, they may demand abolishing prisons altogether, except for the people they don't like. Liberals used to celebrate the individual, I remember that. They encourage you to be your own true self, free expression was celebrated. But now, it's really bizarre, because they're all about enforcing their own orthodoxy, their own conformity in speech and belief.

You deviate from their ever changing moving goalposts, and they'll excommunicate you at once. They have no interest in debate, and who can blame them? They can't defend their lousy ideas or their hatred of America, and they have no idea how to make anyone's life better - really better.

So they'd rather distract you with the latest two-minute symbol or hate or maybe

some acapella singing on YouTube, make everyone feel good for the moment. But in the end, it doesn't make anyone's life really better. Certainly doesn't put more money in your pocket.

Today, they're trying to keep us trapped in a never ending cycle of meaningless sloganeering and protest selfies. It's like eating junk food. It tastes good in the moment, but it's not going to make you stronger.

If we had an honest media, they'd do more than just reacting to President Trump's tweets or his walk across the park to St. John Church. They'd be asking tough questions like this. Vice President Biden, if you're such a champion of minorities, why do you oppose educational choice for disadvantaged families in schools?

And if you knew, Mr. Biden, how to heal our racial divide, why didn't you and President Obama do it over the eight years you were in the White House? Why didn't you fight against all those jobs being shipped overseas to China? Why did it take President Trump to pass criminal justice reform?

Fortunately, the whole world hasn't yet become a giant student center. There are still grown up people with real money making real bets on the future. And those people, the investors who drive our markets, they see a very different world from that scrawled on signs by English majors who know more about Pokemon than the founders of our country.

Investors seem to be optimistic about who will win this battle of ideas. Even after a pandemic, and after days of unrest, they're still betting on America. The Dow shot over 26,000 today, stunning. We're coming back. And that means more jobs for Americans of all races and creeds. And who want - would want to protest against that? And that's "The Angle."

Now speaking of twisting the data, the left is doing just that to fuel the narrative that police departments are inherently systemically racist. So what are the numbers actually tell us? According to a "Washington Post" database that tracks these numbers.

Police officers fatally shot 1,004 people - 1,004 people in 2019 of those only 41 were unarmed. If you break those numbers down among race you find 20 of the unarmed were white, while 10 were black. As long as we're looking at those numbers, according to the FBI 89 police officers - 89 were killed in the line of duty last year.

Joining me now is former NYPD Commissioner Bernie Kerik, and Dr. Oscar Odom former NYPD detective. Bernie, how damaging is it to building police community relationships, when no one talks about these numbers and the truth of how police are

trying to make this situation better under very difficult circumstances?

COMMISSIONER BERNIE KERIK, FORMER NYPD COMMISSIONER: You know what, Laura, in real communities with real community leaders, real community activists, local police precincts, they have great relationships. Local police stations in smaller towns, they have great relationships.

The problem comes is when you have one of these incidents, and the community is concerned, and then you have all the rebel rousers, you have the anarchist, you have the rioters, you have the thugs, they all ship themselves into that community and they go haywire.

And then the mainstream media, CNN and NBC, MSNBC, any others, they all promote it as its community unrest and the community is sick and tired of police brutality. The reality is, most of those communities have phenomenal relationships with the cops.

They need the cops, especially, especially the minority and the communities of color, because in a lot of scenarios, those are the precincts, those are - the communities they have the most violence. And the whole picture of systemic racism is a farce and the numbers show.

INGRAHAM: But it's being used as a cudgel and as a weapon against, I think, the good people, Dr. Odom, who are - and I believe in the inherent goodness of people. I really do. I'm not going to be a pessimist watching some of the violence on the streets. But I know Dr. Odom, you are so upset about this bail reform - so called bail reform, and what it means for the looters and the destructors of personal property and businesses. Tell us about that.

DR. OSCAR ODOM, FORMER NYPD DETECTIVE: Yes, well, one of the things first of all I like to say, I'd like to thank the women and men and blue of the NYPD for doing such a fantastic job out there. Despite what else anybody says, we know you're doing a great job, the best police department in the world. Keep up the good work. We're behind you.

One of the things that we look at with this bail reform is we see they're flip flopping so much on the bail reform now, because they don't know exactly what they really want to do. The thing has so many different flaws in it when you see that, if people are coming out, just like now, with the different rioting and they're being led right back out again to commit more crimes, this is causing more problems in New York City.

We have COVID-19 now. Businesses are losing money. We're trying to regain money and put people back to work and put things back together and get the economy going again. By doing, this is just a farce and it causes so many different issues and so many

different problems.

They have this set up and it's not set up with any checks and balances to say that if we're going to let you out, we're going to follow up with you. We're going to beat it with you. We're going to check on you, we're going to do all these different things.

No, they just say you don't have it, we let you out, go out there and do whatever you want to do. That's causing the problem and that's one of the things that is messing up the criminal justice system. It's also messing up the economy, and it's also messing up everything. It's making it tougher for policing, because of the fact that you have to keep on rearresting, rearresting, rearresting people over.

INGRAHAM: They're same people.

ODOM: Yes, over and over again.

INGRAHAM: You see the same thing, Bernie, in California. So I keep - I mean, we've been exposing Mayor de Blasio, Bernie, a night after night after night. The man, I'm sorry to say this, is a disgrace, how he has handled this situation. It is disgraceful to see a city, that I've lived in temporarily and I love, to see this happening to the city, it's a disgrace. Yet, this is this movement for, "bail reform" happening in California. It's being pushed by the same people who are - some of them are causing trouble on the streets.

KERIK: Yes. Laura, listen, Dr. Odom, everything he said just now is absolutely right. And what you said about de Blasio is correct. He's the most incompetent Mayor we've ever had. But here's the bottom line.

Where's Governor Cuomo? Where is he? Because he's the guy that's responsible for the state. He's also the guy that signed into law in New York state the bail reform. The bail reform that lets all of these criminals that are arrested for mayhem, for arson, for burglary for looting, for assaults to get right back out on the street and Governor Cuomo did that.

INGRAHAM: Well, at least he urged everybody to sing along with him John Lennon's "Imagine" song. He did accomplish that today, which maybe we'll get to.
Unbelievable. All right, gentlemen, thank you so much.

And earlier today, former President Obama live stream his thoughts on the current state of play in our country.

(BEGIN VIDEO CLIP)

BARACK OBAMA, 44TH U.S. PRESIDENT: What has happened over the last several

weeks is challenges and structural problems here in the United States have been thrown into high relief. They're the result of a long history of slavery and Jim Crow and redlining and institutionalized racism, but too often have been the plague, the original sin of our society.

(END VIDEO CLIP)

INGRAHAM: Well, I just can't keep asking this question. He was President for eight years. For the first two years of that he had a Democrat House and a Democrat Senate. So was nothing redeemed in those eight years when he was elected twice by majority of white voters? I just keep asking that same question. You were there.

Joining me now is Angela Stanton-King, Goddaughter of Dr. Alveda King and candidate for Georgia's 15th Congressional District. Angela, like Barack Obama is a smart guy. I mean, he's a global superstar. He has so much influence, I think, and he could have real positive influence here.

But, instead, we get a lot of bromides about systemic problems and old prejudices, but I don't see how that ever gives people a job or a sense of, of self-worth or independence. I just - it seems like we're going around in circles. I can't hear There she is. Here we go.

ANGELA STANTON-KING, GODDAUGHTER OF DR. ALVEDA KING: It does, and that's one of the reasons why I decided to run for Congress. One of the things that I realized is, I'm going against long-term incumbent John Lewis.

And John Lewis, 40 years ago, when he marched across the Selma bridge, we were fighting the same injustices we're fighting today. So that tells me that something in leadership did not happen. So the same thing with Obama and Joe Biden and their White House.

I think about all of the cases that were up under their watch in their administration when it comes to Kalief Browder, when it comes to Tamir Rice when it comes to Trayvon Martin, Sandra Bland, the list goes on and on. I personally would have liked to seen Obama and Joe Biden do much more to come against what they're saying now is this police brutality and this law minus systemic racism.

INGRAHAM: Angela, this was what Eric Holder, a former Attorney General said today. Watch.

ERIC HOLDER, FORMER U.S. ATTORNEY GENERAL: Stereotypes. Born in slavery, and

the notion that, in order to enslave people, you have to think that they were in some ways different, some ways inferior, those attitudes may not be as explicit as they once were, but still are part, I think, of the American psyche.

INGRAHAM: Angela, I mean, again, their argument is America is a horrible, awful, racist country and it's just completely paralyzed by racism. He was the Attorney General of the United States, went to the top schools in America. So many incredible success stories across the country.

Of course, there's racism and injustice, there is probably always going to be, sadly, but it seems to just discount all of the wonderful things that our country does and has done for people of all backgrounds. And it's such a negative view. I just--

STANTON-KING: It's such a negative view and I have to challenge that, because if America is so bad, why are they fighting so hard to open our borders for all of these illegal immigrants to just flow into our country and have access to opportunity?

So America isn't as bad as they're trying to proclaim it to be. I think right now what we need to do is get away from this victimhood mentality, and go on to be making America great, being great, doing all that we can, to fight against injustice, to stand for justice, and do what's right.

What I'm seeing now is a lot of people coming together. A lot of people saying, Hey, what happened to George Floyd was wrong and demanding justice. A lot of people are peacefully protesting, but we can't overlook those that are coming together to destroy our communities and cause so many problems. I think that America is really ready to move right past racism, but will the media let us?

INGRAHAM: Now, well, I think a lot of people, frankly, make a lot of money on pushing the same tired old narratives that never create a single job in the United States or a single opportunity. Angela, thank you so much.

And we need to get back to Washington, where they've pushed back their curfew, check this out, four hours. OK, from 7:00 pm to 11:00 pm. What could go wrong? A reasonable question might be, is someone trying to encourage the chaos for some type of political benefit? It just seems to defy common sense.

After I was out there Sunday night, and it was 11:00 pm curfew and things got pretty crazy, lighting things on fire, including St. John Church. Fox's, Kevin Corke is on the streets of DC right now with the latest. Kevin, what can you tell us?

KEVIN CORKE, FOX NEWS WHITE HOUSE CORRESPONDENT: Well, it is inexplicable when you think about it. If you have a curfew that you push back, you're likely going to get more people on the street after 11:00 pm, which is when the latest curfew has been instituted by the Mayor Muriel Bowser.

As you see here, we're just That's north of St. John's Church and the crowd is fairly large. Now you probably can also tell there is a line of National Guardsmen just beyond the crowd. We've actually moved up a half block from Lafayette Park yesterday. Of course, we're right along H Street. We're about a half block up from there.

So what is the real question tonight is, what will happen once we get to 11:00 o'clock, 11:30, 12:00 o'clock? I can tell you this, Laura, for the balance of the day, it's been speeches, it's been chants, and not much else. But, of course, we'll all be watching carefully as it gets ever later. Back to you for now,

INGRAHAM: Kevin, thanks so much. And while it's obvious to pretty much everyone with a brain that Antifa is instigating a lot of the devastation that we've been seeing, the media wants you, of course, to believe otherwise.

CHRIS CUOMO, CNN HOST, CUOMO PRIME TIME: They talk about Antifa and Black Lives Matter and the radical left all the time, and you know who has benefited these ones? Nationalists and the bigots, because they get defended.

JOY REID, MSNBC HOST: There are groups, anarchists, white nationalists, other groups that are attracted and as the day goes on, they start to pop up.

INGRAHAM: So what do the actual professional say? Actually people who study this. One DOJ official telling Fox News, "I have seen the actual Intel showing Antifa has been involved in outside agitation. I've seen very little in the way of any far right groups, but we're looking and that may be out there."

My next guest has spent decades studying and infiltrating the groups the media are now blaming for inciting the riots. Joining me now is Terry Turchie, former Deputy Assistant Director of the FBI is Counter-Terror Division, who led the unabomber and the Olympic bombing investigations. Also with me is Jim Casey, 25 year FBI vet who's supervised an FBI squad in the Midwest that investigated militia, neo Nazi and anarchist groups.

Terry, what is going on here? I mean, when you see people dressed in clown masks, throwing Molotov cocktails toward or in police vehicles and the bricks on the streets, piling them up passing them out to people. What is this?

TERRY TURCHIE, FMR FBI DEP DIR, COUNTERTERRORISM: Well, it certainly looks to me like the far left radical type element that has been with us for a long time. Now, that's not to say there aren't going to be people that take advantage of that.

But this is really a very similar photograph picture to what was happening in America in the 1960s and 1970s. In the late 1960s, we had The Black Panther Party advent itself in Oakland, and they self-described themselves as a Marxist Leninist group dedicated to the overthrow of the United States government.

They advocated no police in their community. They advocated arming their own people, and their main issue with systemic racism, police, racism, police brutality. They've made a lot of trips to China. Their key guy - the founder of the organization Huey Newton, in a speech to Boston College in 1970 said, "We are for nothing more and nothing less than the complete overthrow the United States government. We want the total transformation."

Weather Underground came along in the 1970s. And the Weather Underground, in fact, created what they call Prairie Fire manifesto. And every issue that is out there today, including gestures of the raised clenched fist, all of this and especially police brutality, police racism, America is systemically racist, the Weather Underground, put into Prairie Fire and said, look, we take these, these incidents as they come and we then magnify them, and this is how we're going to overthrow the U.S. government.

They really believed that. Here's the big problem, and I'll stop. That philosophy and those words have been transplanted into the 2016 Democratic Party platform. You just played clips from Barack Obama and Eric Holder, and I will tell you, when you're audience don't take my word for it. Go online and Google Prairie Fire and Google The Black Panther Party Ten-Point plan and you could make a case that they read those words directly from those documents. I will leave the rest up to the people to decide.

INGRAHAM: All right, that is disturbing. Now, Jim, you have seen anarchist groups exhibit certain characteristics. Can you outline briefly what your experience has been with those organizations, and what are the tells?

JIM CASEY, RETIRED FBI SPECIAL AGENT IN CHARGE: So I'll congratulate Terry for that insight, and he's exactly right, and take it to the next generation, which was what we saw with the World Trade Organization protests in Seattle, and the ALF EFL, the Animal Liberation Front and Earth Liberation Front protests in the late 90s and early 2000s. The Occupy Wall Street, these are all just iterations of the same anarchists, and

that is what we are seeing with the current violence in our cities right now.

INGRAHAM: Jim and Terry, we're going to have you back tomorrow night. We have to keep this conversation going. Thank you so much. Sorry it's so short.

And former defense secretary James Mattis decided today was the day to unload on President Trump, saying "Donald Trump is the first president in my lifetime who does not try to unite the American people, does not even pretend to try. Instead he tries to divide us. We owe it to our fellow citizens, to past generations that bled to defend our promise and to our children."

Joining me now is retired General Robert Spalding, former senior director of strategy at the NSC. General Spalding, I am not surprised in the slightest that General Mattis said what he said. I think he's still mad that Trump wanted to try to pull troops out of the Middle East and that Trump asked NATO to up its dues. I didn't think he liked any of that, and he's never much liked Trump ever sense.

GEN. ROBERT SPALDING (RET), FORMER SENIOR DIRECTOR FOR STRATEGY AT NSC: I feel like there is a disconnect in Washington, D.C. Having been part of the national security establishment, you get the impression that people in D.C. that are working in the bureaucracy have forgotten what America is about, have forgotten the American people.

And the president has a responsibility to protect the American people. We have looting, we have violence, we have destruction of property, and I think he's done what he has to do. And if you need to do more, you can remember that Herbert Hoover in 1932 called then Colonel MacArthur to clean out to Washington, D.C., because the veterans from World War I were protesting. So this is something that the president has authority to do and, quite frankly, Americans are looking to him to lead to protect them.

I would say one other thing, Antifa, as they have been declared a terrorist organization, you've noticed that we've had peaceful protest since then. I'm wondering if a lot of people that were donating money to that are now worried that Treasury, FBI, and DOJ are going to start to dig in their bank records and find out who has been supporting these people.

INGRAHAM: That's a great point. We were told there were all these weapons of mass destruction in Iraq, and I was very, very supportive of going in. And that war went on and on and on, I became less supportive of what it was doing to our country and our troops. And weapons of mass destruction, we have weapons that are being used on our street against our people, our economy, and the history of our country, and just our psyche, our national psyche.

And so for James Mattis to call Trump the problem, are you kidding me? With all due respect to his amazing service to the country, I find it offensive at this time in our history you attack the president who is trying to bring order to the situation? It seems he is upset about the military troops being brought to bear perhaps in our cities. What is the alternative if the city starts really burning, if Antifa really starts running the show? Just let it burn, I guess. Save Iraq, but let America burn. OK, try to run a campaign on theft and see many people will vote for it, Robert.

SPALDING: For 20 years we let the Chinese take the working class jobs. Then we had coronavirus, which small businesses were destroyed. And now we have the riots where 52nd street in Philadelphia, everything is gone. So working-class feels like they are at war with everybody, and really the president is trying to protect them, I think.

INGRAHAM: And I can tell you, all the people who are going to vote for Joe Biden, all the people doing their trashing of Trump online, they are in favor of all of these policies to send jobs, including minority jobs, overseas. They are in favor of continuing these wars that have sent a lot of minorities to die for countries other than our own. So that is what they're going to be in favor of, and that is what they're going to do if Joe Biden becomes president of the United States. That's not going to not help a lot of the minorities in this country, I can tell you that. Thank you, Robert.

And future NFL Hall of Fame quarterback Drew Brees has come under significant fire tonight from the leftist thought police. His crime, he said he would never disrespect the flag. Raymond Arroyo is here, he'll break it all down in "Seen and Unseen" next.

INGRAHAM: Its' time for our ""Seen and Unseen" segment where we reveal the stories behind the headlines. Joining us with all the details, Raymond Arroyo, FOX News contributor. Raymond, I am so upset about what is happening to Saints quarterback Drew Brees. He finds himself in this scalding cauldron of hate, and I'm going to underline the word "hate" given what his teammates are saying about comments he posted today about the Kaepernick protest. Tell us what's going on.

RAYMOND ARROYO, FOX NEWS CONTRIBUTOR: They asked him today on Yahoo! what can we expect for the NFL season of giving thick Kaepernick protests? Should they continue? Here's what he said.

DREW BREES, NFL QUARTERBACK: I will never agree with anybody disrespecting the flag of the United States of America or our country. Let me just tell you what I see or

what I feel when the National Anthem is played, and when I look at the flag of the United States. I envision my two grandfathers who fought for this country during World War II.

ARROYO: Laura, Brees also said that he thinks about the civil rights leaders and the movement and their sacrifices when he hears that Anthem. But that wasn't enough for some of his teammates. Saints receiver Michael Thomas tweeted "We don't care if you don't agree or whoever else. How about that." There were calls on the Internet to cancel the quarterback. Then Saints safety Malcolm Jenkins recorded a response to Drew. He suggested that Brees shut the f-up. And added this.

MALCOLM JENKINS, NEW ORLEANS SAINTS SAFETY: I'm disappointed, I'm hurt, because while the world tells you that you're not worthy, that your life doesn't matter, the last place you want to hear it from are the guys that you go to war with and that you consider to be allies and to be your friends.

ARROYO: But Laura, Brees actually said the opposite. Look, there is a lot of pain here, and you can hear that. But Drew Brees did not cause it, and he did not say black lives were not worthy. He actually said, and I'm quoting from his video, "God created us all equal and we have a responsibility to love and respect each other." There is a danger either/or mentality at play -- either disrespect the flag and the anthem with a particular program, or you're a racist. This is absurd. There are many Americans who died, including a lot of African-Americans, to defend that flag, and we have to honor them as well and come together. And we are seeing, you can come together and you can protest. They are not mutually exclusive.

INGRAHAM: He is allowed to have his view about kneeling and the flag means to him. He is a person. He has some worth, I would imagine. This is beyond football, though. This is totalitarian conduct. This is Stalinist. And by the way, on the streets of New Orleans, we're looking at life pictures, they are shouting "F-- Drew Brees."

ARROYO: That's amazing to me.

INGRAHAM: That's what this moment has done to the beautiful team spirit of the New Orleans Saints.

ARROYO: He is a great Christian man. He's a class act.

INGRAHAM: He has given \$5 million to charities in New Orleans, by the way.

ARROYO: This breaks my heart, and I hope we as a family, a Saints family, can come together. You know I'm a big Saints fan.

Laura, I'm going to jump ahead. There's another story we have to hit. President Trump, who visited the John Paul II shrine the other day, he is facing his own firestorm. The president went there to underscore the signing of an international religious freedom executive order. People reacted horribly, including the Archbishop of Washington, Wilton Gregory, who said this. We'll put it up on the screen for you. And then I will go ahead. Here's what he said, "I find it baffling and reprehensible that any Catholic facility would allow itself to be so egregiously misused and manipulated in a fashion that violates our religious principles."

Now, Laura, I don't recall any cries of misuse or manipulation of Catholic facilities last year when this happened. That is Speaker Nancy Pelosi, an ardent abortion advocate, a public dissenter from church teaching, at Wilton Gregory's cathedral last year. Was there any public bafflement over that appearance? I don't think so.

The other thing here, Laura, Wilton Gregory, I don't know why he would make this so partisan and so political. Everyone is welcome in the shrine, anybody.

INGRAHAM: Right. He's also honoring the anniversary of John Paul II trip to Poland in 1979 --

ARROYO: Correct.

INGRAHAM: -- I believe as well. Wilton Gregory, he is more of the leftist, progressive archbishop, and that is fine, but the president didn't do anything wrong, and he seems like he's politicizing the Catholic faith while Nancy Pelosi and all these other advocates for abortion and everything, they just get a free pass. It's ridiculous. We have got to go.

ARROYO: Something reprehensible and baffling is when you have someone like Wilton Gregory who is very close to the egregious and infamous abuser, Theodore McCarrick. He spent many Thanksgivings with him. We still don't have the report how McCarrick, his misdeeds were covered up. I would like to see that. That's egregious and baffling.

INGRAHAM: Show us the documents, Archbishop, please show us those documents. Raymond, thanks so much.

And in moments we check in on Minneapolis, plus my response to the hydroxy haters and how they were all fooled by that bogus "Lancet" study. Don't go away.

(COMMERCIAL BREAK)

INGRAHAM: Minneapolis is where all the chaos started, so how are things in the city after a week of protest and some looting? Mike Tobin is live in Minneapolis with an update to the case. Mike?

MIKE TOBIN, FOX NEWS SENIOR CORRESPONDENT: It seems, Laura, the only demonstration in town is this one at the site where George Floyd was killed. I ballpark it at about 500 people here. And it really fits the definition of a peaceful protest.

This, of course, coming on a day of big developments. The charges against Derek Chauvin were upgraded to second-degree murder. The other officers connected to this case are now spending their first night behind bars. Thomas Lane, Tou Thao, J. Alexander Kueng, all booked into the Hennepin County jail tonight, charged with aiding and abetting. The bond is \$1 million.

The people out here say they're not necessarily satisfied with the charges. They want to see some fundamental changes, they say. And as far as demonstrating on the street, they say the demonstrations will continue to an undefined period of time until they feel satisfied.

At this location, we're less than 15 minutes away before the curfew, this particular location has a tendency to go past the curfew, but there's no trouble here and cops usually just let it go, Laura.

INGRAHAM: Mike, thanks so much tonight.

And the riots raging across the country and other cities may be coming the airwaves, but we're not going to let the left get away with this one. A couple of weeks back the medical establishment and the WHO seized on a study published in the "Lancet" medical journal that claimed hydroxychloroquine increased the risk of death in COVID patients. Of course, the media was happy to pile on.

UNIDENTIFIED MALE: These findings in the "Lancet," which is a very influential medical journal, simply deepen the impression that the president has been reckless in his promotion of this drug.

UNIDENTIFIED FEMALE: Clearly a deadly message, a fatal message for those with vulnerabilities.

UNIDENTIFIED FEMALE: Those who were given the drug the president has been huckstering for, suffered a significantly higher risk of death.

UNIDENTIFIED MALE: Let's bring in Dr. Sapan Desai. He is one of the lead researchers of this study.

UNIDENTIFIED MALE: People are scared. They're looking for solutions. And chloroquine, hydroxychloroquine, especially when combined with the macro light, the risk of death goes up.

INGRAHAM: Except now we know that the "Lancet" study was based on lies, and that man you just saw, Dr. Sapan Desai, is key to it all. According to a damning expose in "The Guardian," Desai was feeding researchers extremely flawed data through a shady little company he founded called Surgisphere. It's basically a shell company with just three employees, one of whom is a science fiction writer and another who is an adult content model.

On top of that, Desai has been named in three previous medical malpractice lawsuits. More importantly, though, how many COVID patients went untreated or died because this sham study was weaponized for political purposes?

Joining me now is Dr. Harvey Risch, professor of epidemiology at the Yale School of Medicine. Dr. Risch, how did "Lancet" and the WHO get fooled?

DR. HARVEY RISCH, YALE SCHOOL OF PUBLIC HEALTH: Good evening, Laura. What I think happened here is that peer review is good but it's not perfect. And reviewers tend to be as critical or not depending on whether they like the results that they see. And if the study comes up with results that they are motivated to want, then they're less likely to be as critical as they should be, or vice versa.

INGRAHAM: A new study came out today that is being cited in the mainstream media by Dr. Boulware, and they are saying that that study was randomized and it shows that there is no benefit of early use of hydroxychloroquine involving 800 patients. But our medical team has been digging into that as well. What can you tell us about that?

RISCH: That study was, indeed, randomized, but it did not have no effect. It showed 17 percent benefit of taking hydroxychloroquine preventively. There is another study in India that has also shown a benefit, but that study took six days in order to show a benefit, and the Boulware study I think lasted only for five days of treatment. So it's uncertain.

But the main problem with the Boulware study is that it teste for prevention people who are 30 to 50 years old, they are more or less low risk. They had few if any other chronic diseases. And so those are people who aren't likely to be hospitalized even if they get COVID-19 and generally are not the ones you're going to treat. What we need to be treating as outpatients are high-risk people over 60 or with lots of other convictions.

INGRAHAM: And we should actually test them. Only two percent of the patients in the Boulware study were actually tested to confirm that they had COVID, correct?

RISCH: That's true, but I'm actually not a strict tester per se. I think that the symptoms at this time of year are pretty clear and you can pretty will distinguish COVID-19 here because there's very little influenza, and seasonal allergies are totally different. So there is not much competition for those symptoms.

INGRAHAM: And Dr. Risch, just one other point. There was a Brazilian study that has gotten very little play that I know you cited in your article that led you, I believe, to think that hydroxychloroquine should be widely available in an outpatient setting. What about that study?

RISCH: That study was a controlled study, not a randomized study, but it was done in a clinic and an HMO that is a private clinic that is independent of government pressure, that is very highly regarded in Brazil by other clinicians in the country. And that study showed a benefit of taking hydroxychloroquine plus azithromycin. And like many studies, people who take the medications or are given the medications tend to be sicker than the ones who aren't, because after all, clinicians think that they need more medications to try to help them.

So in spite of having more serious symptoms of the COVID-19 and more chronic conditions, they did better in avoiding hospitalization by taking the medications.

INGRAHAM: And finally, in 15 seconds or so, Doctor, after you published your piece critical of the "Lancet" study and advocating on behalf of hydroxychloroquine, what did you hear from other doctors who treat COVID patients?

RISCH: So after I published my paper in the "American Journal of Epidemiology" last week, I've heard from hundreds of physicians who have been very supportive of the message, which is that outpatient disease is a totally separate entity that needs to be evaluated and treated on its own without regard to what happens in hospital.

INGRAHAM: Dr. Risch, thank you so much. We really appreciate your expertise.

And coming up a wake-up call for the Black Lives Matter crowd in the Last Bite in
