### D. Federal Building Damage

- Approximately **150 federal buildings** damaged between 29 May and 5 June, according to DHS Federal Protective Service (FPS) reporting. Note: FPS protects over 9,000 federal facilities. Overall federal building damage estimates could be larger as FPS is not responsible for protecting all federal buildings (1800 CTS Intel Summary June 5)
- Notable Examples:
  - Open investigation into partially detonated PVC pipe bomb recovered from lobby of MI Secretary of State's office space (in a building shared with the federal bankruptcy court) early Sunday. (USAO Activity Report June 5 0800)



(CNN June 4 1630) • Case Highlight: Three self-identified members of the Boogaloo movement were charged with conspiracy to damage and destroy by fire and explosive. These three defendants met over the past two months to discuss their plans to violently overthrow the U.S. government, including by exploiting George Floyd's death to stir confusion and cause rioting. On May 30, the defendants agreed to take part in a Black Lives Matter protest in Las Vegas. Before the protest, law enforcement observed them preparing Molotov cocktails. ### F. Potential Hotspots

- *Houston, Texas.* Three services for Mr. Floyd are planned for June 8 and 9 in the Houston area, which could spark various types of unrest. Although the North Carolina memorial service remained peaceful, there was significant potential for problems. Converging on the public viewing and service, for example, were large contingents from opposing organizations, including several hundred members of OutKast motorcycle gang, a small group of heavily armed and validated new Black Panther Party members, and various members of the Crips. Although tensions were high at times, the interactions remained peaceful.
- *Pennsylvania.* A Philadelphia police inspector was charged after being filmed hitting an individual in the back of the head with a metal baton during a gathering. (DHS NOC Interim Update, 7 JUN 0400)
- Virginia. On 6 June in Richlands VA, a 23-year-old "incel" suffered injuries to his

- *Virginia.* Intelligence indicates a white confederate group (NFI) is planning to protest aT the Lee Monument in Richmond VA today at 1300-1500 with a counter protest planned at the same time. (USAO Activity Report, 5 JUN 1944)
