(Attempted Online Enticement of a Minor to Engage in Prostitution)

On or about September 18, 2023, in Burlington County, in the District of New Jersey, and elsewhere, defendant

Louis Goldenberg

did, using the mail or any facility or means of interstate or foreign commerce, knowingly persuade, induce, entice and coerce any individual who has not attained the age of 18 years, to engage in prostitution or any sexual activity for which any person can be charged with a criminal offense, or attempted to do so.

In violation of Title 18, United States Code, Section 2422(b).

ATTACHMENT B

I, Aliya Simnor, being duly sworn, do hereby depose and state:

I. BACKGROUND

- 1. I have been a Special Agent with the U.S. Department of Homeland Security ("DHS"), Homeland Security Investigations ("HSI") since 2020. As a Special Agent, I am authorized to investigate violations of laws of the United States, and I am a law enforcement officer with the authority to execute warrants issued under the authority of the United States.
- 2. I make this affidavit in support of an arrest warrant for Louis Goldenberg (GOLDENBERG), for a violation of Title 18, United States Code, Section 2422(b), attempted enticement of a minor to engage in prostitution.
- 3. The statements contained in this affidavit are based upon my investigation, information provided by other HSI agents and law enforcement officers, and my experience and training as a Special Agent.
- 4. Because this affidavit is being submitted for the limited purpose of securing a criminal complaint, I have no included each and every fact known to me concerning this investigation. I have set forth only the facts that I believe are necessary to establish probable cause to arrest GOLDENBERG for the crime of attempted enticement of a minor to engage in prostitution, in violation of Title 18, United States Code, Section 2422(b).

II. FACTS SUPPORTING PROBABLE CAUSE

- 5. On July 24, 2023, an HSI agent, working in an undercover capacity ("UC"), created a post on DoubleList¹ to assist in identifying child predators seeking to sexually exploit children. The undercover post was titled, "F@mily Adventures," and the description included the following, "Hi, looking for like minded people who want to join in some family adventures. Not looking for anyone who uses drugs. Must be a nice person;)." The post advertised for the Philadelphia, Pennsylvania area.
- 6. On August 10, 2023, GOLDENBERG replied to the ad using a Google email address that contained his name. The email signature attached to the responses from email address stated, "Louis Goldenberg xxx-xxx-1688." The picture associated with the email account was a picture of a white male standing in front

of a fence. The following is an excerpt of the conversation between GOLDENBERG and the undercover email account ("UCE") that occurred on August 10, 2023:

GOLDENBERG 5:58 PM: Sounds HOT and I'm interested. Can send more info

if still looking

UCE 8:14 PM: Hi, sure what stuff are u into? I'm an aunt² with a 12

year old niece³

GOLDENBERG 8:18 PM: Role play has been a fantasy of mine and would love to

live out a family scenario. Aunt & uncle. Bro & sis, etc What do

you think?

UCE 8:23 PM: What do you mean by role play? Between me and you or

you and her?

GOLDENBERG 8:24 PM: What type of adventures are you into? 8:26 PM: You and I but not opposed to all three

GOLDENBERG 8:34 PM: Are we remotely on the same page? This is me.

Below is the picture sent from GOLDENBERG to the UCE.

7. On August 10, 2023, at 9:53 PM, GOLDENBERG, using the email address jeffstrong215@gmail.com, replied for the first time to the same DoubleList ad he replied to using the Google email address that contained his name. The following is an excerpt of the conversations between GOLDENBERG and the UCE that occurred between August 10 and August 23, 2023:

GOLDENBERG August 10, 2023 9:53 PM: Hey - I am a 40 year old

professional living in Center City and would like to know

more about your family adventures and possibly join in

UCE August 11, 2023 10:57 AM: Hi, 'm 36 an aunt and I have a

12 year old niece. What are you interested in? I'm just cross

the bridge lol on the jersey side

GOLDENBERG August 19, 2023 1:33 PM: I'm fine with Jersey. Especially

with a 36 aunt and her 12 year old niece. Sounds HOT

8. On August 23, 2023, GOLDENBERG suggested to the UCE that they communicate using Kik Messenger. Between August 23 and September 15, 2023, GOLDENBERG continued to communicate with the undercover agent, via Kik Messenger, to discuss setting up payment options as well as a time and location for GOLDENBERG to have sex with "Maddie." The following are some of the conversations that took place between GOLDENBERG and the undercover Kik Account (UCK) that occurred between August 24 and September 11, 2023.

UCK August 24, 2023: So u said u like them young? Do u

think 12 is good for u?

GOLDENBERG August 24, 2023: I think it's hot and will be fun if she like

being with older men

GOLDENBERG August 24, 2023: I am totally turned on by it and looking

forward

. . .

Based upon on my training and experience I know that the phrase "young video" is street language for pornographic videos featuring underage children, also known as Child Sexual Abuse Material ("CSAM").

The true identity of Hotel 1 is known to law enforcement.

- 9. On September 18, 2023, at approximately 6:00 PM, GOLDENBERG arrived at Hotel 1 in Mount Laurel Township, New Jersey. Agents executed a probable cause arrest and apprehended GOLDENBERG as he attempted to check in to the hotel.
- 10. During the search incident to arrest, GOLDENBERG was found to be in possession of \$300.
