INFORMATION

The defendant having waived in open court prosecution by Indictment, the United States Attorney for the District of New Jersey charges:

From on or about August 3, 2020, through on or about August 6, 2020, in the District of New Jersey, and elsewhere, the defendant,

SUNIL VAID,

using the mail and any facility and means of interstate and foreign commerce, did knowingly persuade, induce, entice, and coerce, and attempt to persuade, induce, entice, and coerce, MINOR VICTIM, an individual who had not attained the age of eighteen years, to engage in sexual activity for which any person could be charged with a criminal offense, believing that MINOR VICTIM was under the age of eighteen.

In violation of Title 18, United States Code, Section 2422(b).

FORFEITURE ALLEGATION

1. The United States hereby gives notice that upon conviction of the defendant of the offense in violation of 18 U.S.C. § 2422(b) charged in this Information, the United States will seek forfeiture of all right, title, and interest of the defendant in any property, real or personal, that was used or intended to be used to commit or to facilitate the commission of such offense, and any property, real or personal, constituting or derived from any proceeds the defendant obtained, directly or indirectly, as a result of such offense, pursuant to 18 U.S.C. § 981(a)(1)(C) and 28 U.S.C. § 2461, and 18 U.S.C. § 2428.

2. The property to be forfeited includes, but is not limited to, all right, title and interest of the defendant in the following item seized from the residence of the defendant on or about October 18, 2022:

- (a) A Dell desktop, bearing serial number 36978382082.

Substitute Assets Provision

3. If any of the above-described forfeitable property, as a result of any act or omission of the defendant:

- (a) cannot be located upon the exercise of due diligence;
- (b) has been transferred or sold to, or deposited with, a third person;
- (c) has been placed beyond the jurisdiction of the Court;
- (d) has been substantially diminished in value; or
- (e) has been commingled with other property which cannot be subdivided without difficulty;

it is the intent of the United States, pursuant to 21 U.S.C. § 853(p), as incorporated by 28 U.S.C. § 2461(c), to seek forfeiture of any other property of the defendant up to the value of the forfeitable property listed above.
