<u>SUPERSEDING INFORMATION</u>

The defendant having waived in open court prosecution by Indictment, the United States Attorney for the District of New Jersey charges:

COUNT ONE

(Possession of a Firearm and Ammunition by a Convicted Felon)

On or about February 11, 2021, in Essex County, in the District of New

Jersey and elsewhere, the defendant,

TAUREAN GORDON,

knowing that he had previously been convicted in a court of at least one crime punishable by a term of imprisonment exceeding one year, did knowingly possess in and affecting commerce a firearm and ammunition, namely, a loaded North American Arms Inc. .22 caliber revolver, model NAA-22LR, bearing serial number V76056, and five (5) rounds of .22 caliber ammunition.

In violation of Title 18, United States Code, Section 922(g)(1).

COUNT TWO

(Possession with Intent to Distribute Controlled Substances)

On or about February 11, 2021, in Essex County, in the District of New Jersey and elsewhere, the defendant,

TAUREAN GORDON,

did knowingly and intentionally possess with the intent to distribute a quantity of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance; a quantity of a mixture and substance containing a detectable amount of N-Phenyl-N-[1-(2-phenylethyl)-4piperidinyl]propanamide (Fentanyl), a Schedule II controlled substance; and a quantity of a mixture and substance containing a detectable amount of heroin, a Schedule I controlled substance.

In violation of Title 21, United States Code, Sections 841(a)(1) and (b)(1)(C).

COUNT THREE

(Possession of a Firearm in Furtherance of a Drug Trafficking Crime)

On or about February 11, 2021, in Essex County, in the District of New Jersey and elsewhere, the defendant,

TAUREAN GORDON,

in furtherance of a drug trafficking crime for which he may be prosecuted in a court of the United States, namely, the possession with intent to distribute cocaine, fentanyl, and heroin charged in Count Two of this Superseding Information, did knowingly possess a firearm, namely a North American Arms Inc. .22 caliber revolver, model NAA-22LR, bearing serial number V76056.

In violation of Title 18, United States Code, Section 924(c)(1)(A)(i).

FORFEITURE ALLEGATION AS TO COUNTS ONE AND THREE

As a result of committing the firearms offenses charged in Counts One and Three of this Superseding Information, the defendant,

TAUREAN GORDON,

shall forfeit to the United States, pursuant to Title 18, United States Code, Section 924(d)(1), and Title 28, United States Code, Section 2461(c), any firearm and ammunition involved in or used in the commission of such offenses, including, but not limited to, one North American Arms Inc. .22 caliber revolver, model NAA-22LR, bearing serial number V76056; and five (5) rounds of .22 caliber ammunition.

FORFEITURE ALLEGATION AS TO COUNT TWO

As a result of committing the controlled substance offense charged in Count Two of this Superseding Information, the defendant,

TAUREAN GORDON,

Shall forfeit to the United States of America, pursuant to Title 21, United States Code, Section 853, any and all property constituting or derived from any proceeds obtained directly or indirectly as a result of the said offense, and any and all property used or intended to be used in any manner or part to commit and to facilitate the commission of the offense alleged in Count Two of this Superseding Information.

Substitute Assets Provision

If any of the property described above, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third party;
- c. has been placed beyond the jurisdiction of the court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be divided without difficulty,

it is the intent of the United States, pursuant to Title 21, United States Code, Section 853(p), as incorporated by Title 28, United States Code, Section 2461(c), to seek forfeiture of any other property of the defendant up to the value of the above forfeitable property.
