CREPPY, Appellate Immigration Judge

On August 4, 2023, Evidentiary Panel 8-6 of the District 8 Grievance Committee of the State Bar of Texas issued an order suspending the respondent from the practice of law in Texas for 5 years. The Panel imposed an active suspension of 18 months beginning July 20, 2023, and stated that this active suspension would be shortened to 12 months if the respondent presented proof of employment with a supervising attorney.

On March 8, 2024, the Disciplinary Counsel for the Executive Office for Immigration Review and the Disciplinary Counsel for the Department of Homeland Security ("DHS") jointly petitioned for the respondent's immediate suspension from practice before the Board of Immigration Appeals, the Immigration Courts, and DHS. The petition will be granted. See 8 C.F.R. §§ 1003.103(a)(1) and (4) (discussing grounds for immediate suspension).

ORDER: The petition is granted, and the respondent is hereby suspended from the practice of law before the Board of Immigration Appeals, the Immigration Courts, and DHS pending final disposition of this proceeding. 8 C.F.R. § 1003.103(a)(4).

FURTHER ORDER: The respondent shall promptly notify, in writing, any clients with cases currently pending before the Board of Immigration Appeals, the Immigration Courts, or DHS that the respondent has been suspended from practicing before these bodies.

¹ Upon good cause shown, the Board of Immigration Appeals may set aside the order of immediate suspension when it appears in the interest of justice to do so. 8 C.F.R. § 1003.103(a)(4).
