2. Each of the defendants transacts business and is found within the Central District of California.

THE DEFENDANTS

3. R & G Sloane Manufacturing Company, Inc. (hereinafter referred to as "Sloane, Inc.") is hereby made a defendant Sloane, Inc. is a corporation organized on August 28, herein. 1969 and existing under the laws of the State of Delaware, with its principal place of business in Sun Valley, California. During the period of time covered by this complaint, Sloane, Inc. engaged in the business of manufacturing and distributing DWV plastic pipe fittings. Sloane, Inc.'s sales of DWV plastic pipe fittings for the year 1970 amounted to approximately \$8,000,000.

14 4. The Susquehanna Corporation (hereinafter referred to ~ 15 as "Susquehanna") is hereby made a defendant herein. Susquehanna 16 is a corporation organized in 1953 and existing under the laws of 17 the State of Delaware, with its principal place of business in 18 Alexandria, Virginia. On or about December 4, 1967, Susquehanna 19 merged with Atlantic Research Corporation, hereinafter named as 20 a co-conspirator, and thereby acquired the business and assets of 21 the latter corporation used in the manufacture and distribution of DWV plastic pipe fittings. On or about August 28, 1969, 22 23 Susquehanna organized Sloane, Inc., a wholly-owned subsidiary, 24 and on or about October 1, 1969 transferred to Sloane, Inc. its 25 business and assets used in the manufacture and distribution of DWV plastic pipe fittings. From on or about December 4, 1967 to 26 on or about October 1, 1969, Susquehanna engaged in the business 27 of manufacturing and distributing DWV plastic pipe fittings under 28 29 the style of R & G Sloane Manufacturing Company, a division of 30 Susquehanna.

Celanese Corporation (hereinafter referred to as 5. "Celanese") is hereby made a defendant herein. Celanese is a corporation organized as The American Cellulose and Chemical 4 Manufacturing Company, Ltd. in 1918 under the laws of the State of Delaware. In 1927, its corporate title was changed to 6 Celanese Corporation of America and, on or about April 13, 1966, its title was again changed to Celanese Corporation. Said defendant's principal place of business is in New York, New York. During the period of time covered by this complaint, Celanese has engaged in the business of manufacturing and distributing DWV plastic pipe fittings. Celanese's sales of DWV plastic pipe fittings for the year 1970 amounted to approximately \$5,000,000.

14 6. Borg-Warner Corporation (hereinafter referred to as 15 "Borg-Warner") is hereby made a defendant herein. Borg-Warner 16 is a corporation organized on September 20, 1967 and existing 17 under the laws of the State of Delaware, with its principal 18 place of business in Chicago, Illinois. Borg-Warner is the 19 successor corporation of Borg-Warner Corporation, a corporation 20 organized in 1928 under the laws of the State of Illinois, and 21 each reference hereinafter to Borg-Warner includes its predecessor 22 corporation. During the period of time covered by this complaint, 23 Borg-Warner has engaged in the business of manufacturing and distributing DWV plastic pipe fittings. 24 In March 1971, Borg-25 Warner discontinued engaging in such business. Borg-Warner's sales of DWV plastic pipe fittings for the year 1970 amounted 26 27 to approximately \$2,800,000.

7. Plastiline, Incorporated (hereinafter referred to as "Plastiline") is hereby made a defendant herein. Plastiline is a corporation organized in 1946 and existing under the laws of the State of New York, with its principal place of business in

Pompano Beach, Florida. During the period of time covered by this complaint, Plastiline has engaged in the business of manufacturing and distributing DWV plastic pipe fittings. Plastiline's sales of DWV plastic pipe fittings for the year 1970 amounted to approximately \$2,300,000.

III

CO-CONSPIRATORS

8. Atlantic Research Corporation, a corporation organized in 1949 under the laws of the Commonwealth of Virginia, and various other corporations, companies and individuals not made defendants in this complaint participated as co-conspirators with the defendants in the offense alleged herein and performed acts and made statements in furtherance thereof.

IV

TRADE AND COMMERCE

9. DWV plastic pipe fittings are used as a means of providing turns, connections, branches, traps, splits and the like in drainage, waste or vent systems in fixed residential, modular and mobile homes and other structures. In the United States, DWV plastic pipe fittings are generally made from one of two types of thermoplastics, varying proportions of acrylonitrile, butadiene and styrene monomers (ABS) and from polyvinyl chloride (PVC). The principal types of DWV plastic pipe fittings include adapters, bushings, cleanouts, flanges, couplings, elbows, plugs, bends, tees, traps and Y's. DWV plastic pipe fittings have, to a substantial degree, replaced fittings made of cast iron, steel, copper and other materials during recent years.

10. During the period of time covered by this complaint, substantial quantities of DWV plastic pipe fittings manufactured by defendants Sloane, Inc., Susquehanna, Celanese, Borg-Warner

and Plastiline, and by co-conspirator Atlantic Research Corporation, at plants in California, Florida, Missouri and Ohio were shipped and sold by such defendants and co-conspirator to customers located in states other than the states in which such DWV plastic pipe fittings were manufactured. During the year 1970, the total dollar volume of sales of DWV plastic pipe fittings in the United States was approximately \$32,000,000, of which defendants Sloane, Inc., Celanese, Borg-Warner and Plastiline accounted for approximately 54 percent.

OFFENSE ALLEGED

11. Beginning at least as early as January 1966, the exact date to the plaintiff being unknown, and continuing thereafter up to and including the date of the filing of this complaint, the defendants and co-conspirators have engaged in a combination and conspiracy in unreasonable restraint of the aforesaid interstate trade and commerce in DWV plastic pipe fittings, in violation of Section 1 of the Act of Congress of July 2, 1890, as amended (15 U.S.C. § 1), commonly known as the Sherman Act. Said offense is continuing and will continue unless the relief hereinafter prayed for in this complaint is granted.

12. The aforesaid combination and conspiracy has consisted of a continuing agreement and concert of action among the defendants and co-conspirators to fix, maintain and stabilize discounts and prices in connection with the sale of DWV plastic pipe fittings.

13. For the purpose of forming and effectuating the aforesaid combination and conspiracy, the defendants and co-conspirators have done those things which, as herein-before alleged, they have combined and conspired to do.

EFFECTS

VI

14. The aforesaid combination and conspiracy has had, among others, the following effects:

(a) discounts and prices on DWV plastic pipe
fittings sold by the corporate defendants and co conspirators have been fixed, maintained and stabilized;

(b) price competition among the corporate defendants and co-conspirators in the sale of DWV plastic pipe fittings has been suppressed; and

(c) customers of the corporate defendants and co-conspirators have been deprived of the opportunity to purchase DWV plastic pipe fittings at competitive prices.

VII

PRAYER

WHEREFORE, the plaintiff prays:

I. That the aforesaid combination and conspiracy be adjudged and decreed to be unlawful and in violation of Section 1 of the Sherman Act.

2. That each of the corporate defendants, its successors, assignees and transferees, and the respective officers, directors, agents and employees thereof, and all persons acting or claiming to act on behalf thereof, be perpetually enjoined and restrained from continuing to carry out, directly or indirectly, the combination and conspiracy hereinbefore alleged, or from engaging in any other combination or conspiracy having a similar purpose or effect, or from adopting or following any practice, plan, program or device having a similar purpose or effect.

3. That the corporate defendants, their successors, assignees and transferees, and their respective officers, directors, agents and employees, and all persons acting or claiming to act on behalf thereof, be perpetually enjoined and restrained from exchanging or divulging to any competitor information concerning prices, discount terms, pricing intentions, pricing methods or any term or condition affecting the price of DWV plastic pipe fittings and related products which they sell, except upon such terms as the Court may deem necessary to the legitimate conduct of their businesses.

4. That the Court, where appropriate, enter an order requiring each of the corporate defendants within sixty (60) days following entry of a final judgment in this action, to:

> (a) withdraw its presently effective price list and prevailing prices and discount terms for DWV plastic pipe fittings;

(b) individually review its prices and discount terms for DWV plastic pipe fittings on the basis of its individual cost figures and individual judgment as to profit; and

(c) adopt new prices and discount terms and issue a new price list and discount sheet for DWV plastic pipe fittings on the basis of such independent review.

5. That the defendants be required to take such further action as the Court may deem necessary and appropriate to terminate and dissipate the effects of the unlawful activities hereinabove alleged, and to permit and restore competition in the sale of DWV plastic pipe fittings.
