the state and the defendants, under our law have a certain number 64 1 of what is called peremptory challenges; that is to say, both 2 the state and the defendants have a right to ask that a certain 3 prospective juror be excused without assigning any cause for it. 4 Cause would be some situation or condition whereby you have 5 indicated that in all probability you could not sit as a proper 6 juror. For instance, if you said that by information that had 7 come to you, you had already made up your mind as to the guilt 8 or innocence of the defendants without having heard the evidence, 9 obviously you could not serve properly here; and other informa-10 tion might be brought out by questioning you whereby it would 11 be clear that in all probability you could not properly serve 12 and so you would be excused. That would be for cause. But, 13 of in addition to that, each side has a number, as I said,/per-14 emptory challenges, that is to say, for reasons satisfactory to 15 themselves up to a certain number without stating any cause. 16 If they didn't like the color of the dress you are wearing or 17 the color of your shirt or the way you part your hair or for 18 some reason wholly satisfactory to him without giving any ex-19 planation you might be excused. If you are so excused, you 20 should not take that to mean that your honesty or integrity is 21being questioned; that will not be the case. It simply means 22 that for some reason satisfactory to the respective parties 23 that you should not sit, and so, others will be called. MR. STROUD: Ladies and gentlemen, as his Honor has 4 already referred to, I am Jay Stroud. I am with the District 5 Solicitor's Office in the Fifth Judicial District which is 6 New Hanover and Pender Counties. It is my function in this 7 trial to prosecute the cases on behalf of the State of North 8 Carolina. The State of North Carolina is for all practical 9 10 purposes the plaintiff in this action, and so, I will be representing the State of North Carolina in these cases, in the 11 12 prosecution aspect of these cases. Now, as you know, when you 13 were present in the court room yesterday, we have on trial here eleven defendants, all of whom are seated over here with 14 15 their attorneys. All eleven of these defendants are charged 16 with at least two and most of them are charged with three 17 felonies. The three felonies involved are conspiring to assault 18 emergency personnel, police officers and firemen, with a 19 deadly weapon; the second charge is conspiring to burn a 20building with an incendiary device, to-wit: a fire bomb or a 21 gas bomb; and third, the actual burning of a building with an 22 incendiary device, to-wit: a fire bomb or a gas bomb. Now, 23these as alleged in the bills of indictment, these offenses 24 took place in February, of 1971, February a year ago, in 25 Wilmington, North Carolina. The two conspiracies are alleged

So, we are talking a two day period of time in 5 February, of 1971. The building involved was Mike's Grocery 6 Store, located on Sixth Street, in Wilmington. It's a two-7 story -- As alleged in the bill of indictment, it's a two-story 8 wooden frame building. So, these are basically the allegations 9 as contained in the bills of indictment on which the defendants 10 are being tried at this time. Now, all of the defendants, with 11 the exception of Miss Shepard seated here and Mr. Kirby who is 12 the third gentleman here, all of the defendants with the 13 exception of these two are charged with all three of the crimes 14 I've referred to: conspiring to assault emergency personnel 15 with a deadly weapon, police officers and firemen; conspiring 16 to burn a building with an incendiary device; and burning the 17 building with an incendiary device. Mr. Kirby and Miss Shepard 18 are charged with two crimes: conspiring to assault emergency 19 personnel with a deadly weapon, to-wit, firemen and police 20officers; and secondly, conspiring to burn the building with 21an incendiary device. They are not - these two defendants -22 are not charged with burning the building. So, we have eleven 23defendants, thirty-one charges in all.
