REFUSED DUE TO INSUFFICIENT
UNDER THE INFORMATION ACT

This display contains selected reprints of rejected applications of Negroes. These Negroes were denied registration for their failure to give a reasonable interpretation of a Constitutional provision to the satisfaction of the Registrar. A study of their applications demonstrates that the Interpretation Test is "a calculated scheme to lay snares" for Negro citizens.
