MICHAEL F. McAULIFFE, State Attorney for the Fifteenth Judicial Circuit, Palm Beach County, Florida, by and through his undersigned Assistant State Attorney, charges that:

COUNT 1: MARY GAYLE TOMASHESKI between November 1, 2006 and January 31, 2010, in the County of Palm Beach and State of Florida, did knowingly obtain or use, or endeavor to obtain or use U.S. Currency of a value of \$50,000.00 or more, which was the property of BARBARA BERMANSKI and ABRAHAM BERMANSKI, a person 65 years of age or older, knowing or having reason to believe that BARBARA BERMANSKI and ABRAHAM BERMANSKI was 65 years of age or older, with the intent to permanently or temporarily deprive BARBARA BERMANSKI and ABRAHAM BERMANSKI of the property or benefit therefrom or to appropriate the property to the use of MARY GAYLE TOMASHESKI or to the use of any person not entitled thereto, contrary to Florida Statute 812.0145(2)(a). (1 DEG FEL)

COUNT 2: MARY GAYLE TOMASHESKI between November 1, 2006 and January 31, 2010, in the County of Palm Beach and State of Florida, did engage in a scheme constituting a systematic, ongoing course of conduct with intent to defraud one or more persons, or to obtain property from one or more persons by false or fraudulent, representations, or promises, and did obtain property from one or more of such persons in an aggregate value of \$50,000.00 or more, contrary to Florida Statute 817.034(4)(a)1. (1 DEG FEL)
