INDICTMENT

The Grand Jury charges:

COUNT ONE

Between in or about April 2014 and continuing to in or about June 2015,
in Manatee County, in the Middle District of Florida and elsewhere,

NATHAN ALEXANDER BRYAN,

the defendant herein, did use a facility of interstate and foreign commerce, to wit:
a cellular telephone and computer with access to the internet, to knowingly
attempt to persuade, induce, entice, and coerce an individual who had not
attained the age of eighteen years to engage in a sexual act for which any
person can be charged with a criminal offense.

In violation of Title 18, United States Code, Section 2422(b).

COUNT TWO

On or about June 6, 2015, in the Middle District of Florida, the defendant,
NATHAN ALEXANDER BRYAN,
did knowingly employ, use, persuade, induce, entice, and coerce a minor, herein
identified as "John Doe" age six, to engage in sexually explicit conduct for the
purpose of producing, and attempting to produce, any visual depiction of such
conduct, using materials that have been mailed, shipped, and transported in and
affecting interstate and foreign commerce by any means, including by computer.

In violation of Title 18, United States Code, Section 2251(a).

FORFEITURE

1. The allegations contained in Counts One and Two of this
Indictment are hereby realleged and incorporated by reference for the purpose of
alleging forfeitures, pursuant to the provisions of Title 18, United States Code,
Section 2428.

2. Upon conviction of the violations alleged in Counts One and Two of
this Indictment, in violation of Title 18, United States Code, Sections 2422 and
2251(a), the defendant,

NATHAN ALEXANDER BRYAN,

shall forfeit to the United States of America, pursuant to Title 18, United States
Code, Section 2428:

- a. any property, real or personal, that was used or intended to
be used to commit or to facilitate the commission of the
violation; and

- b. any property, real or personal, constituting or derived from any proceeds obtained, directly or indirectly, as a result of the violation.
3. The specific property to be forfeited includes, but is not limited to:
 - a. One generic black computer tower with New Age Technology Solutions #2164 sticker on side of computer;
 - b. Hitachi 320GB SATA hard drive, S/N 111022E20342331014NP removed from generic black computer tower;
 - c. White ZTE cell phone, model 2740G, S/N 322540822742
 - d. Nextbook tablet, S/N YFG0414008014; and
 - e. One 1993 red, four door, Oldsmobile eighty eight, VIN: 1G3HN53L5PH314049.
4. If any of the property described above, as a result of any act or omission of the defendant:
 - a. cannot be located upon the exercise of due diligence;
 - b. has been transferred or sold to, or deposited with a third party;
 - c. has been placed beyond the jurisdiction of the court;
 - d. has been substantially diminished in value; or
 - e. has been commingled with other property which cannot be divided without difficulty,

the United States of America shall be entitled to forfeiture of substitute property pursuant to Title 21, United States Code, Section 853(p), as incorporated by Title 28, United States Code, Section 2461(c).


