INFORMATION

The defendant having waived in open court prosecution by indictment, the United States Attorney for the District of New Jersey charges:

From in or around May 2014 through in or around September 2014, in Morris County, in the District of New Jersey, and elsewhere, the defendant,

DAVID M. ADAMS,

did, using the mail and any facility and means of interstate and foreign commerce, knowingly persuade, induce, entice, and coerce an individual who had not attained the age of 18 years to engage in sexual activity for which any person could be charged with a criminal offense, and attempted to do so.

In violation of Title 18, United States Code, Section 2422(b).

FORFEITURE ALLEGATIONS

1. The allegations contained in this Information are hereby realleged and incorporated by reference for the purpose of alleging forfeiture pursuant to Title 18, United States Code, Section 2428(a).

2. Upon conviction of the offense set forth in this Information, the defendant, DAVID M. ADAMS, shall forfeit to the United States of America:

a. Any property, real or personal, that was used or intended to be used to commit or to facilitate the commission of the offense; and

b. Any property, real or personal, that constitutes or is derived from proceeds traceable to the offense.

The property to be forfeited includes, but is not limited to, the following:


- (1) Sager Notebook – Serial # 8C06SC949579;
- (2) iBuyPower Tower, iSeries 901- Serial # 473A-9D41-2A4F-1F8A;
- (3) Sony Mobile Snap Camera, model MHS-TS55, Serial # 0505258;
- (4) Nikon Coolpix S210 Camera, # 34133817;
- (5) Western Digital hard drive, 320GB, serial # WCAPD4124790;
- (6) Samsung SSD EVO, Serial # S1DHNSAF832869W;
- (7) Samsung Galaxy S5, serial # R38FA008G7E; and
- (8) Apple iPad, serial # DMQHRH7TDJ8R.

3. If any of the property described above, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;

- b. has been transferred or sold to, or deposited with, a third party;
- c. has been placed beyond the jurisdiction of the Court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be divided without difficulty,

the United States of America shall be entitled to forfeiture of substitute property pursuant to Title 21, United States Code, Section 853(p), as incorporated by Title 18, United States Code, Section 2428 and by Title 28, United States Code, Section 2461(c).
