INDICTMENT

The Grand Jury charges:

COUNT ONE

Beginning on an unknown date, but not later than on or about

November 27, 2017, and continuing through on or about the date of this

indictment, in the Middle District of Florida, and elsewhere, the defendants,

JESUS MANUEL RODRIGUEZ, a/k/a "Caltu," BRYAN GOMEZ NEVAREZ, HECTOR JOSE CARRASOUILLO PEREZ, a/k/a "Tito," HENRY COIRA, LUIS ENRIQUE HERNANDEZ OUINONES. a/k/a "Gordo," AVISYS LEE JACKSON. JAVIER ALBALADEJO LOPEZ. a/k/a "the Barber," JOSE ANGEL MENDOZA, JR., PEDRO LUIS RAMOS BURGOS, WILLIAM LEVERNE NORTON. a/k/a "Cool," EDGAR HERNANDEZ. a/k/a "Chuck," and ISMAEL PAGAN MARRERO,

did knowingly, willfully, and intentionally conspire with each other and other persons, both known and unknown to the Grand Jury, to possess with intent to distribute a controlled substance.

With respect to all defendants, the violation involved 5 kilograms or more of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance and is therefore punished under 21 U.S.C. § 841(b)(1)(A)(ii).

In violation of 21 U.S.C. § 846.

COUNT TWO

On or about January 7, 2018, in the Middle District of Florida, and elsewhere, the defendants,

JESUS MANUEL RODRIGUEZ, a/k/a "Caltu," and PEDRO LUIS RAMOS BURGOS,

did knowingly and intentionally possess with intent to distribute a controlled substance, which violation involved 500 grams or more of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance and is therefore punished under 21 U.S.C. § 841(b)(1)(B).

In violation of 21 U.S.C. §§ 841(a)(1) and 841(b)(1)(B)(ii), and 18 U.S.C. § 2.

COUNT THREE

On or about January 13, 2018, in the Middle District of Florida, and elsewhere, the defendants,

JESUS MANUEL RODRIGUEZ, a/k/a "Caltu," and WILLIAM LEVERNE NORTON, a/k/a "Cool,"

did knowingly and intentionally possess with intent to distribute a controlled substance, which violation involved 500 grams or more of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance and is therefore punished under 21 U.S.C. § 841(b)(1)(B). In violation of 21 U.S.C. §§ 841(a)(1) and 841(b)(1)(B)(ii), and 18 U.S.C. § 2.

COUNT FOUR

On or about January 17, 2018, in the Middle District of Florida, and elsewhere, the defendants,

JESUS MANUEL RODRIGUEZ, a/k/a "Caltu," and JAVIER ALBALADEJO LOPEZ, a/k/a "the Barber,"

did knowingly and intentionally possess with intent to distribute a controlled substance, which violation involved 500 grams or more of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance and is therefore punished under 21 U.S.C. § 841(b)(1)(B).

In violation of 21 U.S.C. §§ 841(a)(1) and 841(b)(1)(B)(ii), and 18 U.S.C. § 2.

COUNT FIVE

On or about January 17, 2018, in the Middle District of Florida, and elsewhere, the defendants,

JESUS MANUEL RODRIGUEZ, a/k/a "Caltu," and BRYAN GOMEZ NEVAREZ,

did knowingly and intentionally possess with intent to distribute a controlled substance, which violation involved 500 grams or more of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance and is therefore punished under 21 U.S.C. § 841(b)(1)(B).

In violation of 21 U.S.C. §§ 841(a)(1) and 841(b)(1)(B)(ii), and 18 U.S.C. § 2.

COUNT SIX

On or about January 24, 2018, in the Middle District of Florida, and elsewhere, the defendants,

JESUS MANUEL RODRIGUEZ, a/k/a "Caltu," and WILLIAM LEVERNE NORTON, a/k/a "Cool,"

did knowingly and intentionally possess with intent to distribute a controlled substance, which violation involved 500 grams or more of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance and is therefore punished under 21 U.S.C. § 841(b)(1)(B).

In violation of 21 U.S.C. §§ 841(a)(1) and 841(b)(1)(B)(ii), and 18 U.S.C. § 2.

COUNT SEVEN

On or about March 1, 2018, in the Middle District of Florida, and elsewhere, the defendants,

JESUS MANUEL RODRIGUEZ, a/k/a "Caltu," and HECTOR JOSE CARRASQUILLO PEREZ, a/k/a "Tito,"

did knowingly and intentionally possess with intent to distribute a controlled substance, which violation involved 500 grams or more of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance and is therefore punished under 21 U.S.C. § 841(b)(1)(B).

In violation of 21 U.S.C. §§ 841(a)(1) and 841(b)(1)(B)(ii), and 18 U.S.C. § 2.

COUNT EIGHT

On or about March 2, 2018, in the Middle District of Florida, and elsewhere, the defendant,

JESUS MANUEL RODRIGUEZ, a/k/a "Caltu," and JOSE ANGEL MENDOZA, JR.,

did knowingly and intentionally possess with intent to distribute a controlled substance, which violation involved 500 grams or more of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance and is therefore punished under 21 U.S.C. § 841(b)(1)(B).

In violation of 21 U.S.C. §§ 841(a)(1) and 841(b)(1)(B)(ii), and 18 U.S.C. § 2.

COUNT NINE

On or about March 4, 2018, in the Middle District of Florida, and elsewhere, the defendants,

JESUS MANUEL RODRIGUEZ, a/k/a "Caltu," and LUIS ENRIQUE HERNANDEZ QUINONES, a/k/a "Gordo,"

did knowingly and intentionally possess with intent to distribute a controlled substance, which violation involved 500 grams or more of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance and is therefore punished under 21 U.S.C. § 841(b)(1)(B).

In violation of 21 U.S.C. §§ 841(a)(1) and 841(b)(1)(B)(ii), and 18 U.S.C. § 2.

FORFEITURE

1. The allegations contained in Counts One through Nine are incorporated by reference for the purpose of alleging forfeiture pursuant to the provisions of 21 U.S.C. § 853.

2. Upon conviction of a violation of 21 U.S.C. §§ 846 or 841, the defendants shall forfeit to the United States, pursuant to 21 U.S.C. § 853(a)(1) and (2), any property constituting, or derived from, any proceeds the defendants obtained, directly or indirectly, as a result of such violation, and any property used, or intended to be used, in any manner or part, to commit,

or to facilitate the commission of, such violation.

3. If any of the property described above, as a result of any acts or omissions of the defendants:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third party;
- c. has been placed beyond the jurisdiction of the Court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property, which cannot be divided without difficulty,

the United States shall be entitled to forfeiture of substitute property pursuant

to 21 U.S.C. § 853(p).
