The defendant having waived in open court prosecution by Indictment,  
the United States Attorney for the District of New Jersey charges:

**COUNT ONE:**

**UNLAWFUL DISTRIBUTION OF ANABOLIC STEROIDS**

1. At all times relevant to this Information:
  - a. Defendant KEVIN CUSTIS was a resident of Belle Mead, New Jersey.
  - b. CUSTIS was a practicing physician licensed in New Jersey and New York.
  - c. CUSTIS owned and maintained medical offices in Asbury Park, New Jersey and Brooklyn, New York.
2. Between on or about April 24, 2016, and on or about March 24, 2017, CUSTIS prescribed various types of anabolic steroids, a Schedule III controlled

substance, for two individuals, outside the scope of legitimate medical practice. CUSTIS believed these individuals were obtaining these anabolic steroids solely for use in body enhancement and performance in competitions. CUSTIS did not prescribe the anabolic steroids for any medical diagnosis or any other legitimate medical purpose.

3. The anabolic steroids prescribed by CUSTIS are set forth in the following chart:

The Charge

4. On or about January 12, 2017, in Monmouth County, in the District of New Jersey, and elsewhere, the defendant,

KEVIN CUSTIS,

did knowingly and intentionally distribute and dispense, and possess with the intent to distribute and dispense, a quantity of oxymetholone, a Schedule III controlled substance.

In violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(E)(i), and Title 18, United States Code, Section 2.

**COUNT TWO:**

**POSSESSION WITH INTENT TO DISTRIBUTE MARIHUANA**

1. The allegations set forth in Paragraph 1 of Count One of this Information are realleged and incorporated as if fully set forth herein.
2. On or about June 14, 2017, CUSTIS possessed approximately 4,224 grams of marihuana, a Schedule I controlled substance, and approximately 167 grams of tetrahydrocannabinol, a Schedule I controlled substance, at his residence in Belle Mead, New Jersey.
3. CUSTIS had no license or permission under any federal or state law or regulation to possess, dispense or distribute this marihuana or tetrahydrocannabinol. CUSTIS intended to distribute these substances outside the scope of any legitimate medical practice.

**The Charge**

5. On or about June 14, 2017, in Somerset County, in the District of New Jersey, and elsewhere, the defendant,

KEVIN CUSTIS,

did knowingly and intentionally possess with the intent to distribute and dispense less than 50 kilograms of marihuana, a Schedule I controlled substance.

In violation of Title 21, United States Code, Sections 841(a)(1) and  
841(b)(1)(D), and Title 18, United States Code, Section 2.
