The defendant having waived in open court prosecution by indictment,
the United States Attorney for the District of New Jersey charges:

From in or around September 2017 through on or about February 7, 2018,
in Hudson County, in the District of New Jersey, and elsewhere, the defendant,

RAYFAEL ROMAN,
a/k/a "Ray Bucks,"
a/k/a "Bucks,"

did knowingly and intentionally conspire and agree with others to distribute and
to possess with intent to distribute 500 grams or more of a mixture and
substance containing a detectable amount of cocaine, a Schedule II controlled
substance, contrary to Title 21, United States Code, Sections 841(a)(1) and
841(b)(1)(B).

In violation of Title 21, United States Code, Section 846.

FORFEITURE ALLEGATION

1. The allegations contained in this Information are hereby realleged and incorporated by reference for the purpose of alleging forfeiture pursuant to Title 21, United States Code, Section 853.

2. Pursuant to Title 21, United States Code, Section 853, upon conviction of an offense in violation of Title 21, United States Code, Section 846, the defendant, Rayfael Roman, shall forfeit to the United States of America any property constituting, or derived from, any proceeds obtained, directly or indirectly, as the result of such offense. The property to be forfeited includes, but is not limited to, approximately \$29,938 of United States currency seized from defendant Rayfael Roman's residence on or about February 7, 2018.

3. If any of the property described above, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third party;
- c. has been placed beyond the jurisdiction of the court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be divided without difficulty,

the United States of America shall be entitled to forfeiture of substitute property pursuant to Title 21, United States Code, Section 853(p).
