INDICTMENT

The Grand Jury in and for the District of New Jersey, sitting at Newark, charges:

COUNT ONE
(Conspiracy to Distribute and Possess with Intent to Distribute Heroin and Fentanyl)

From as early as on or about October 17, 2015, through on or about October 19, 2015, in Hudson and Cumberland Counties, in the District of New Jersey, and elsewhere, the defendants,

NOEL SALGADO,
a/k/a "Kuko," and
RODGERICK GARRETT,
a/k/a "50,"
a/k/a "Fif,"
a/k/a "Boo,"

did knowingly and intentionally conspire and agree with each other and others to distribute and possess with intent to distribute a mixture and substance containing a detectable amount of heroin, a Schedule I controlled substance,

and fentanyl, a Schedule II controlled substance, contrary to Title 21, United States Code, Sections 841(a)(1) and (b)(1)(C).

- In violation of Title 21, United States Code, Section 846.

COUNT TWO
(Distribution and Possession with Intent to Distribute Heroin and Fentanyl)

From as early as on or about October 17, 2015, through on or about October 19, 2015, in Hudson and Cumberland Counties, in the District of New Jersey, and elsewhere, the defendants,

NOEL SALGADO,
a/k/a “Kuko,” and
RODGERICK GARRETT,
a/k/a “50,”
a/k/a “Fif,”
a/k/a “Boo,”

did knowingly and intentionally distribute and possess with intent to distribute and did aid and abet the distribution and possession with intent to distribute a mixture and substance containing a detectable amount of heroin, a Schedule I controlled substance, and fentanyl, a Schedule II controlled substance, and serious bodily injury to a person resulted from the use of such mixture and substance distributed by the defendants.

In violation of Title 21, United States Code, Sections 841(a)(1) and (b)(1)(C), and Title 18, United States Code, Section 2.

FORFEITURE ALLEGATION

1. The allegations set forth in this Indictment are hereby realleged and incorporated by reference for the purpose of alleging forfeiture pursuant to Title 21, United States Code, Section 853.

2. As a result of committing the controlled substance offenses in violation of 21 U.S.C. § 846, as charged in this Indictment, the defendants,

**NOEL SALGADO,
a/k/a "Kuko," and
RODGERICK GARRETT,
a/k/a "50,"
a/k/a "Fif,"
a/k/a "Boo,"**

shall forfeit to the United States of America, pursuant to 21 U.S.C. § 853, any and all property constituting or derived from any proceeds obtained directly or indirectly as a result of the said offenses, and any and all property used or intended to be used in any manner or part to commit and to facilitate the commission of the offenses alleged in this Indictment.

3. If by any act or omission of the defendant any of the property subject to forfeiture described above:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third party;
- c. has been placed beyond the jurisdiction of the court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be divided without difficulty,

the United States shall be entitled, pursuant to 21 U.S.C. § 853(p), to forfeiture of any other property of the defendant up to the value of the above-described forfeitable property.
