INDICTMENT

The Grand Jury charges:

COUNT ONE

On or about May 3, 2019, in the Middle District of Florida, and
elsewhere, the defendant,

COLUMBUS DONAVAN JEFFREY,
a/k/a "hideme1977,"

7 KSK *2019*
KTR

did employ, use, persuade, induce, entice and coerce a minor to engage in
sexually explicit conduct for the purpose of producing visual depictions of
such conduct, and the visual depictions were actually transported and
transmitted using a facility of interstate commerce, that is, via the internet.

In violation of 18 U.S.C. §§ 2251(a) and 2251(e).

COUNT TWO

On or about July 28, 2019, in the Middle District of Florida, and elsewhere, the defendant,

COLUMBUS DONAVAN JEFFREY,
a/k/a "hideme1997," *7 KDF DNS
1CR*

did employ, use, persuade, induce, entice and coerce a minor to engage in sexually explicit conduct for the purpose of producing a visual depiction of such conduct, and the visual depiction was actually transported and transmitted using a facility of interstate commerce, that is, by cellular telephone via the internet.

In violation of 18 U.S.C. §§ 2251(a) and 2251(e).

FORFEITURE

1. The allegations contained in Counts One and Two of this Indictment are hereby re-alleged and incorporated by reference for the purpose of alleging forfeiture, pursuant to the provisions of 18 U.S.C. § 2253.

2. Upon conviction of the violation of 18 U.S.C. § 2251(a) charged in Counts One and Two, the defendant, COLUMBUS DONAVAN JEFFREY, a/k/a "hideme1977," shall forfeit to the United States, pursuant to 18 U.S.C. § 2253, all of his interest in:

a. Any visual depiction described in 18 U.S.C. §§ 2251, 2251A, or 2252, 2252A, 2252B, or 2260 of Chapter 110, United States Code,

or any book, magazine, periodical, film, videotape, or other matter which contains any such visual depiction, which was produced, transported, mailed, shipped, or received in violation of this chapter:

b. Any property, real or personal, constituting or traceable to gross profits or other proceeds obtained from such offense; and


c. Any property, real or personal, used or intended to be used to commit or to promote the commission of such offense or any property traceable to such property.

3. If any of the property described above, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third person;
- c. has been placed beyond the jurisdiction of the Court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be subdivided without difficulty;


the United States shall be entitled to forfeiture of substitute property pursuant to 21 U.S.C. § 853(p), as incorporated by 18 U.S.C. § 2253(b).


