COUNT ONE

The Grand Jury charges:

1. On or about November 19, 2019, in the Southern District of New York and elsewhere, OWEN DRAIN, a/k/a "White Boy," a/k/a "Tommy," the defendant, unlawfully and knowingly seized, confined, inveigled, decoyed, kidnapped, abducted, and carried away and held for ransom and reward and otherwise a victim ("Victim-1"), and in so doing, DRAIN willfully caused Victim-1 to be transported in interstate commerce, and used a means, facility, and instrumentality of interstate commerce in committing and in furtherance of the commission of the offense, and aided and abetted the same, to wit, DRAIN used a cellphone to cause Victim-1 to enter a vehicle in the Bronx, New York, where DRAIN zip tied Victim-1 and held Victim-1 at gunpoint.


