INDICTMENT

The Grand Jury in and for the District of New Jersey, sitting at Newark, charges:

COUNT ONE

(Possession of a Firearm and Ammunition by a Convicted Felon)

On or about June 7, 2020, in Passaic County, in the District of New Jersey, the defendant,

EDWIN AAZHONE,

knowing that he had previously been convicted in a court of at least one crime punishable by a term of imprisonment exceeding one year, did knowingly possess in and affecting commerce a firearm and ammunition, namely a 9mm Luger semi-automatic pistol, bearing serial number CZ999-000579, loaded with 15 rounds of 9mm ammunition.

In violation of Title 18, United States Code, Section 922(g)(1).

COUNT TWO

(Possession of a Firearm and Ammunition by a Convicted Felon)

On or about June 7, 2020, in Passaic County, in the District of New Jersey, the defendant,

JAMIR CLARK,

knowing that he had previously been convicted in a court of at least one crime punishable by a term of imprisonment exceeding one year, did knowingly possess in and affecting commerce a firearm and ammunition, namely a .45 caliber Glock semi-automatic pistol, bearing serial number NHP830, loaded with 14 rounds of .45 caliber ammunition.

In violation of Title 18, United States Code, Section 922(g)(1).

FORFEITURE ALLEGATIONS

1. The allegations contained in Counts One and Two of this Indictment are incorporated by reference as though set forth in full herein for the purpose of alleging forfeiture pursuant to Title 18, United States Code, Section 924(d)(1), and Title 28, United States Code, Section 2461(c).

2. Upon conviction of the offense in violation of Title 18, United States Code, Section 922(g)(1), set forth in Count One of this Indictment, the defendant,

EDWIN AAZHONE,

shall forfeit to the United States any firearms and ammunition involved in or used in the commission of such offense, including, but not limited to, the following:

- a. One 9mm Luger semi-automatic pistol, bearing serial number CZ999-000579; and
- b. Fifteen rounds of 9mm ammunition.

3. Upon conviction of the offense in violation of Title 18, United States Code, Section 922(g)(1), set forth in Count Two of this Indictment, the defendant,

JAMIR CLARK,

shall forfeit to the United States any firearms and ammunition involved in or used in the commission of such offense, including, but not limited to, the following:

- a. One .45 caliber Glock semi-automatic pistol, bearing serial number NHP830; and
- b. Fourteen rounds of .45 caliber ammunition.
