The Grand Jury charges that:

**COUNT 1**

(Possession with Intent to Distribute Heroin and Methamphetamine)

On or about July 17, 2021, in the Eastern District of Louisiana, the defendant, **KENDALE ADAMS a/k/a "Kendral Adams," a/k/a "Kendall Adams,"** did knowingly and intentionally possess with intent to distribute a quantity of a mixture and substance containing a detectable amount of heroin, a Schedule I controlled substance and a quantity of a mixture and substance containing a detectable amount of methamphetamine, a Schedule II controlled substance, in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

**COUNT 2**  
(Felon in Possession of a Firearm)

On or about the July 17, 2021, in the Eastern District of Louisiana, the defendant, **KENDALE ADAMS a/k/a “Kendral Adams,” a/k/a “Kendall Adams,”** knowing that he had been convicted of a crime punishable by imprisonment for a term exceeding one year, to wit: a conviction on or about September 28, 2004, in Criminal District Court, Parish of Orleans, under case number 450-484, Section “I,” for possession of crack cocaine, in violation of LA. R.S. 40:967; a conviction on or about May 14, 2008, in Criminal District Court, Parish of Orleans, under case number 453-733, Section “C,” for attempted armed robbery, in violation of LA. R.S. 14:(27)64; a conviction on or about May 14, 2008, in Criminal District Court, Parish of Orleans, under case number 474-254, Section “C,” for possession of ecstasy and possession of heroin, in violation of LA. R.S. 40:966; a conviction on or about January 16, 2009, in the 24<sup>th</sup> District Court, Parish of Jefferson, under Case Number 08-559, Division “B,” for theft of goods, in violation of LA. R.S. 14:67.10; a conviction on or about March 27, 2015, in Criminal District Court, Parish of Orleans, under case number 519-781, Section “I,” for possession of stolen firearms, in violation of LA. R.S. 14:69.1, did knowingly possess in and affecting interstate commerce, a firearm, to wit: a Glock 19, 9 mm semi-automatic handgun, bearing serial number BCKH329, in violation of Title 18, United States Code, Sections 922(g)(1) and 924(a)(2).

**COUNT 3**  
(Carrying a Firearm During the Commission of a Drug Trafficking Crime)

On or about July 17, 2021, in the Eastern District of Louisiana, the defendant, **KENDALE ADAMS a/k/a “Kendral Adams,” a/k/a “Kendall Adams,”** did knowingly carry a firearm, to wit: a Glock 19, 9 mm semi-automatic handgun, bearing serial number BCKH329, during and in relation to a drug trafficking crime for which he may be prosecuted in a court of the United States,

to wit: possession with intent to distribute heroin and methamphetamine, in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C), as charged in Count 1 of this Indictment; in violation of Title 18, United States Code, Section 924(c)(1)(A).

**NOTICE OF FORFEITURE**

1. The allegations of Counts 1 through 3 of this Indictment are incorporated by reference as though set forth fully herein for the purpose of alleging forfeiture to the United States.

2. As a result of the offense alleged in Count 1, the defendant, **KENDALE ADAMS a/k/a “Kendral Adams,” a/k/a “Kendall Adams,”** shall forfeit to the United States pursuant to Title 21, United States Code, Section 853, any property constituting or derived from any proceeds obtained directly or indirectly as the result of said offense, and any property used or intended to be used in any manner or part to commit or to facilitate the commission of said offense.

3. As a result of the offenses alleged in Counts 2 and 3, the defendant **KENDALE ADAMS a/k/a “Kendral Adams,” a/k/a “Kendall Adams,”** shall forfeit to the United States pursuant to Title 18, United States Code, Section 924(d)(1), and Title 28, United States Code, Section 2461(c), any firearm or ammunition involved in or used in the commission of said offenses, including but not limited to the following:

Glock 19, 9 mm semi-automatic handgun, bearing serial number BCKH329.

4. If any of the above-described property, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third person;
- c. has been placed beyond jurisdiction of the Court;
- d. has been substantially diminished in value; or

e. has been commingled with other property which cannot be subdivided without difficulty;

the United States shall seek a money judgment and, pursuant to Title 21, United States Code, Section 853(p), forfeiture of any other property of the defendant up to the value of said property.
