17 INDICTMENT

18 COUNT ONE: [21 U.S.C. § 841(a)(1) – Possession with Intent to Distribute Methamphetamine]

19 The Grand Jury charges: T H A T

20 WILLIAM JOSIAH SCRIVNER,

21 defendant herein, on or about March 23, 2022, in Solano County, State and Eastern District of  
22 California, did knowingly and intentionally possess with intent to distribute at least 50 grams of a  
23 mixture and substance containing a detectable amount of methamphetamine, a Schedule II Controlled  
24 Substance, in violation of Title 21, United States Code, Section 841(a)(1).

25 COUNT TWO: [18 U.S.C. § 922(g)(1) – Felon in Possession of Firearm]

26 The Grand Jury further charges: T H A T

27 WILLIAM JOSIAH SCRIVNER,

28 defendant herein, on or about March 23, 2022, in Solano County, State and Eastern District of

1 California, knowing that he had been convicted of a crime punishable by a term of imprisonment  
2 exceeding one year, specifically:

- 3 (1) Possession of a Controlled Substance, in violation of California Health and Safety Code Section  
4 11350(a), on or about May 28, 2008, in Solano County, California;
- 5 (2) Driving Under the Influence of Alcohol: Causing Bodily Injury, in violation of California Vehicle  
6 Code Section 23153(a), on or about February 23, 2016, in Solano County, California;
- 7 (3) Possession of a Controlled Substance for Sale, in violation of California Health and Safety Code  
8 Section 11378, on March 2, 2020, in Contra Costa County;
- 9 (4) Possession of a Controlled Substance for Sale, in violation of California Health and Safety Code  
10 Section 11378, on March 10, 2021, in Solano County; and,
- 11 (5) Possession of Ammunition by a Prohibited Person, in violation of California Penal Code Section  
12 30305(a)(1), on March 10, 2021, in Solano County;

13 did knowingly possess a firearm, specifically, a Smith and Wesson 9mm semiautomatic pistol bearing  
14 serial number #VAL1392, in and affecting commerce, in that said firearm had previously been  
15 transported in interstate and foreign commerce, in violation of Title 18, United States Code, Section  
16 922(g)(1).

17 FORFEITURE ALLEGATION: [21 U.S.C. § 853(a), 18 U.S.C. § 924(d)(1) and 28 U.S.C. § 2461(c) –  
18 Criminal Forfeiture]

19 1. Upon conviction of the offense alleged in Count One of this Indictment, defendant  
20 WILLIAM JOSIAH SCRIVNER shall forfeit to the United States pursuant to Title 21, United States  
21 Code, Section 853(a), the following property:

22 a. All right, title, and interest in any and all property involved in violation of Title  
23 21, United States Code, Section 841(a)(1), for which defendant is convicted, and all property traceable  
24 to such property, including the following: all real or personal property, which constitutes or is derived  
25 from proceeds obtained, directly or indirectly, as a result of such offense; and all property used, or  
26 intended to be used, in any manner or part to commit or to facilitate the commission of the offense.

27 b. A sum of money equal to the total amount of proceeds obtained as a result of the  
28 offense, for which defendant is convicted.
