Penalties for Indictment

Defendant

TERRY FRANCIS LE CLAIR

COUNT 1:

VIOLATION: 18 U.S.C. § 2251(c) and (e) – Sexual Exploitation of Children

PENALTIES: Mandatory minimum of 15 years in prison and a maximum of 30 years in prison;
Fine of up to \$250,000;
Supervised release of at least 5 years up to life (18 U.S.C. 3583(k));
Forfeiture;
Mandatory Restitution for victims (18 U.S.C. §§ 2259 and 3663);
Mandatory Special Assessments: \$5,100 (18 U.S.C. §§ 3013, 3014)*; and
Registration as a sex offender.

*Note, the mandatory assessments in 18 U.S.C. §§ 2259A do not apply since the date of this alleged crime took place prior to Dec. 7, 2018
