



Additional Charges using Elder Justice Initiative Definitions

Laws vary from state to state and even jurisdiction to jurisdiction. It is critical that a thorough investigation be conducted in accordance with your state's statute. An assessment of the victim's potential to testify should be conducted early on to ensure the most favorable outcome for the victim.

<p>Sexual Abuse</p> <p>is defined as sexual contact or non-contact (e.g., voyeurism) of any kind with an older person without agreement from that person.</p>	<ul style="list-style-type: none"> • Aggravated Assault • Assault • Assault with Sexual Motivation • Battery • Domestic Violence • Elder Abuse • Indecent Liberties • Rape • Sexual Assault • Sexual Battery • Trafficking • Voyeurism
<p>Psychological Abuse</p> <p>is defined as verbal or emotional abuse causing suffering, emotional pain, or distress.</p>	<ul style="list-style-type: none"> • Elder Abuse • Harassment • Hate Crimes • Malicious Harassment • Stalking • Violation of No Contact/Protection Order

<p>Neglect & Abandonment is defined as intentional or unintentional failure or refusal to provide care or help to an older adult to whom a duty of care is already owed. <p>Financial or Material Exploitation is defined as the illegal or improper use of an older person’s money or property.</p>	<ul style="list-style-type: none"> • Elder Abuse • Embezzlement • Exploitation • Forgery • Fraud (credit card, tax, or Medicaid) • Identity Theft • Larceny 	<ul style="list-style-type: none"> • Money Laundering • Obtaining a Signature by Force, Fraud or Coercion • Residential burglary • Theft • Theft of Motor Vehicle • Trafficking
