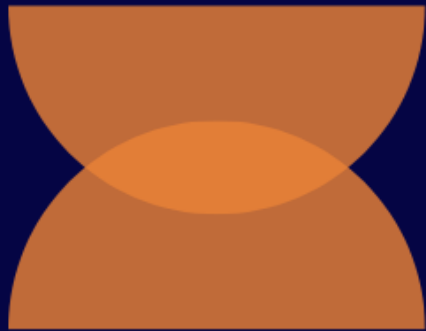

Incorporate Elder Abuse Training Modules into Acadis

The National Clearinghouse on Abuse in Later Life (NCALL) developed a series of 23 training modules on various aspects of law enforcement investigations into elder abuse.

Baltimore has added the complete NCALL elder abuse series to its internal learning management system, **Acadis**, and 1300 Maryland officers have completed the training.

4 Tips from Elizabethtown PD

Some of the best practices our investigators use here locally are:

1. Establish if there are any potential power of attorney documents for the victim.
2. Complete separate interviews for suspect and victim.
3. Determine if cognitive issues exist with the victim.
4. Collaborate with APS to ensure all facts are known about the victim.

Assessing Financial Capacity in Elder Financial Exploitation Cases

The Division of Aging Services (DAS) collaborated with the Alzheimer's Association and Dr. Daniel Marson from the University of Alabama, Birmingham, to develop comprehensive assessment tools to objectively evaluate an individual's capacity to manage their finances.

These assessment tools were field-tested by Adult Protective Services to determine their effectiveness in providing definitive information about an individual's financial capacity.

Certified At-Risk Adult Crime Tactics Specialist (CACTS) Training

Develop a Clear Elder Abuse Protocol and Encourage Collaboration

When we are dispatched to an elder abuse or fraud case involving the elderly, the deputy goes to the complainant's location to get the initial information. In an abuse case, the deputy determines if the victim is safe...has a safe place to go, or if they need medical attention. The deputy would also contact Social Services for any assistance that may be needed for the victim.

Once the deputy has that initial information, and the victim is safe, they will do their report and forward to the investigators. The investigators will take over and schedule interviews with victim and suspect and get the appropriate warrants if necessary. Investigators also send reports to our Aging and Disability Department and inform our district attorneys office. We have ADAs that handle elder abuse cases.

Once it is determined that there is enough evidence for the charges to be filed, our office and DA's office along with Aging Dept. will meet and discuss what is going to happen and what the next steps are. Depending on the victim's understanding of what is taking place, other family members may be involved with the case. We also give the victim and family any information that may help them in this case and resources to help them in the future.

Focus on Issues Relevant to Your Community

We focus mostly on the Grandparent Scam, where a scammer called to say they were the grandchild of the older person and that they were in trouble and needed money. The scammer would instruct the older victim not to tell anyone and to go to the bank and remove money.

We had Officers go to the various banks to educate the tellers of the scam and advise them of the role they can play in interrupting the crime by informing customers who may fit this scenario.

Work Collaboratively with APS

APS workers often have relevant knowledge through prior interactions with alleged victims and perpetrators. Including APS in interviews, and even allowing APS to conduct interviews by themselves, can often be helpful. For instance, APS is required by law to provide the alleged perpetrator with the opportunity to comment on the allegations. Often, we will not join in on this interview with APS. In my experience, alleged perpetrators are more willing to speak candidly (and often inadvertently incriminate themselves) with APS workers, than they are when law enforcement becomes involved and makes its presence known.

Interviewing Victims with Severe Cognitive Impairment

There is often a feeling amongst law enforcement that if a victim has a severe form of dementia or has been deemed legally incapacitated, then there is no reason to interview the victim during the investigation.

In my experience, there can be great value in conducting a recorded interview with these victims, so long as such an interview will not be damaging psychologically to the victim. Often, alleged perpetrators in financial exploitation cases attempt to downplay a victim's cognitive impairment, often claiming that the victim had only mild dementia during the period of charged conduct, or that the victim's deficiencies were not apparent.

Interviewing a victim who has a severe form of dementia within weeks or even months of the alleged unauthorized transactions assist to demonstrate the severity and obviousness of the victim's cognitive limitations. Even though many of these victims will not testify at trial, many of their statements are nonetheless admissible.

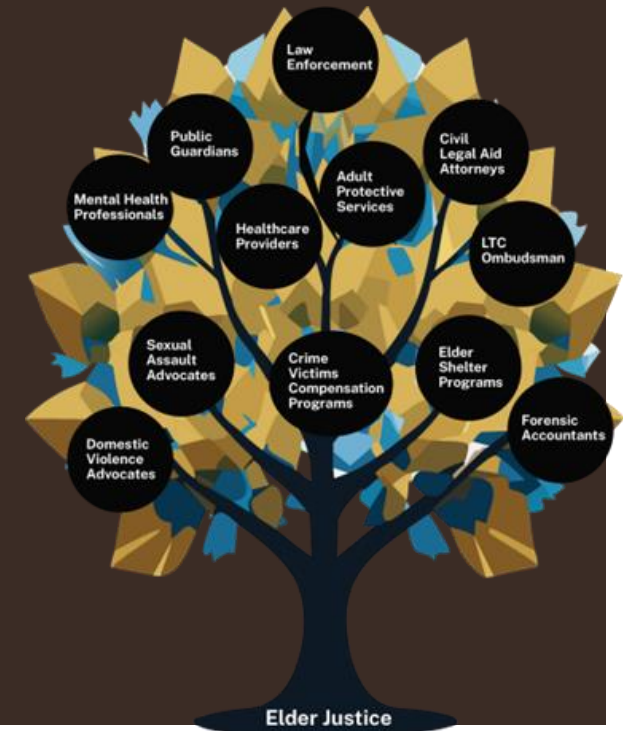


Adult Protective Services (APS)

APS is a state social service program that takes reports of alleged abuse, neglect/self-neglect, and financial exploitation. APS can assess and determine the needs of the elder abuse victim. Most APS offices can share records and information with law enforcement.

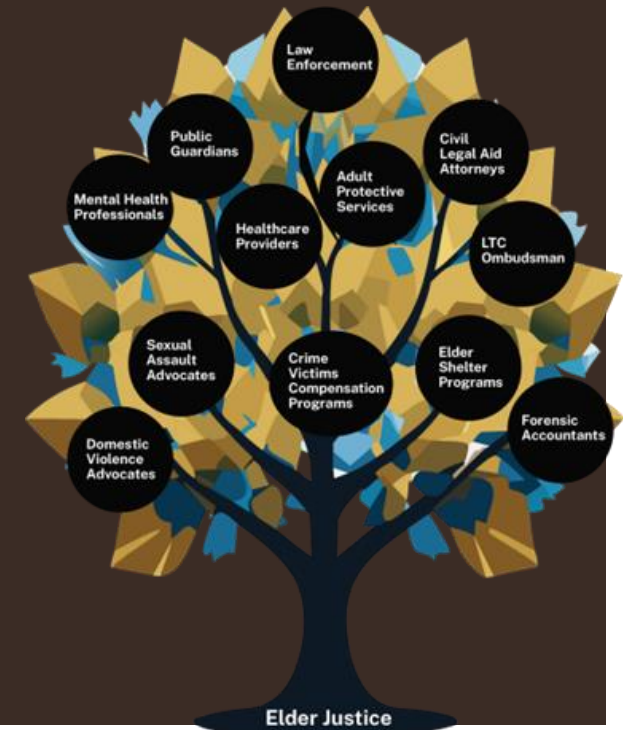

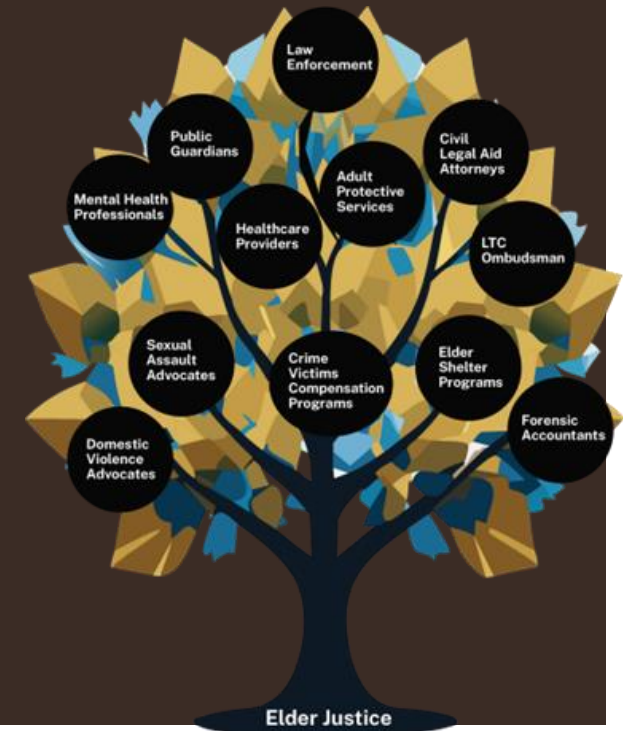
Legal Aid

Legal aid may provide help in filing for a civil protective order, changing a will, appointing a power of attorney, or other legal matters. You may learn during your investigation that a civil legal matter needs to be resolved. You can refer the older victim to Legal Aid.

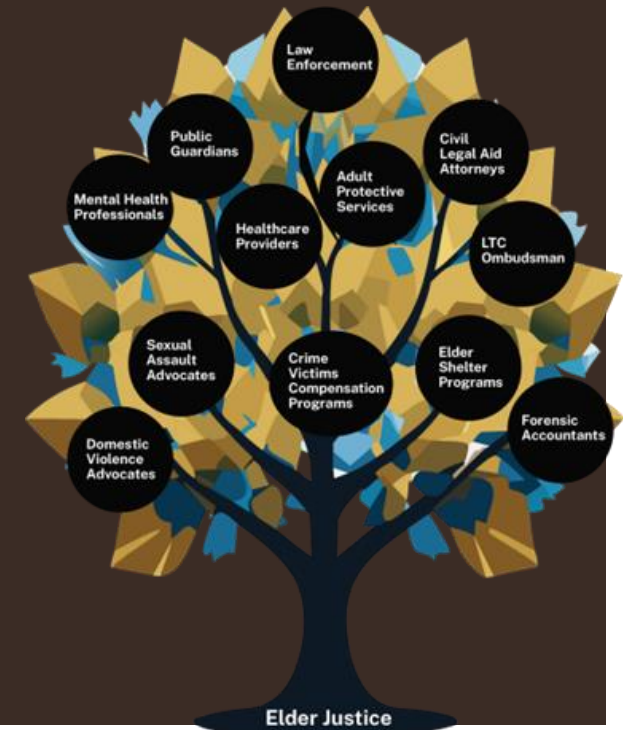


Long-Term Care Ombudsman (LTCO)

The LTCO advocates for the rights of nursing home or Long-Term Care (LTC) residents (in some states also assisted living facilities). When you receive a report of abuse occurring in a LTC facility, contact the LTCO who may know the resident, and will be familiar with the facility.
