Benjamin C. Mizer *Acting Associate Attorney General, U.S. Department of Justice*

Benjamin C. Mizer is the Acting Associate Attorney General for the U.S. Department of Justice. Prior to that, from October 2023 to February 2024, he served as the Principal Deputy Associate Attorney General, and prior to that, Acting Assistant Attorney General for the Office of Legal Counsel. He previously served in multiple roles at the Department of Justice under the Obama-Biden Administrations, including as the Acting Assistant Attorney General for the Civil Division, Principal Deputy Associate Attorney General, Counselor to Attorney General Eric H. Holder, and Deputy Assistant Attorney General in OLC. He also previously served as the General Counsel of the United States Office of Personnel Management and as the Solicitor General for his home state of Ohio.

In addition to his career in public service, Mr. Mizer was a partner in private practice, specializing in appellate and complex litigation.

Mr. Mizer clerked for Justice John Paul Stevens on the U.S. Supreme Court and for Judge Judith W. Rogers on the U.S. Court of Appeals for the District of Columbia Circuit. He graduated from the University of Michigan Law School and the College of Wooster.




Hugh T. Clements, Jr. *Director, COPS Office, U.S. Department of Justice*

Mr. Clements joins the Justice Department after nearly 40 years with the Providence Police Department in Providence, Rhode Island. Mr. Clements started his distinguished public safety career as a night Patrol Officer in Providence's Uniform Division. Over the next 26 years, he rose through the ranks, working in both the Special Investigations Bureau and the Detective Bureau, where he played active roles in several major investigations. He later served as Deputy Chief and was appointed as Acting Chief of Police in July 2011, and on Jan. 6, 2012, he was appointed as the 37th Chief of the Department and promoted to the rank of Colonel.

Mr. Clements has worked closely with major law enforcement, civil rights, and community organizations. He is the recipient of numerous commendations for outstanding police work and devotion to duty, including being recognized with the Providence Police Department Chief's Award three times and the White House Champions of Change Award for Reducing Drug Use and Building a Healthier America.

Mr. Clements received a Bachelor of Arts degree in Sociology from the University of Rhode Island and a Bachelor of Science degree in the Administration of Justice from Roger Williams University. He holds a Master of Science degree in criminal justice from Boston University. He attended many specialty schools throughout his career, including the New York State Police Williams Homicide School, the Illinois State Police Supervisor's School, and the ATF National Gang School in California, and in 2005 he graduated from the Senior Management Institute for Police put on by the Harvard Kennedy School at Boston University.

Gurbir S. Grewal *Director, Division of Enforcement, U.S. Securities and Exchange Commission*


Gurbir Grewal is the Director of the SEC's Division of Enforcement. Immediately before joining the Commission, he was the Attorney General for the State of New Jersey. Prior to that, he served as the Bergen County Prosecutor, the chief law enforcement officer for New Jersey's most populous county. Earlier in his career, Mr. Grewal served as an Assistant United States Attorney for the District of New Jersey, where he was Chief of the Economic Crimes Unit, and an Assistant United States Attorney for the Eastern District of New York, where he was assigned to the Business and Securities Fraud Unit. He also was an attorney in private practice. Mr. Grewal holds a J.D. from the College of William & Mary, Marshall-Wythe School of Law, and a B.S. in Foreign Service from the Georgetown University School of Foreign Service.



Kristina Rose *Director, Office for Victims of Crime, U.S. Department of Justice*

Kristina Rose is the Director of the Office for Victims of Crime (OVC) at the U.S. Department of Justice (DOJ), where she oversees programs and services that support crime victims and survivors. Ms. Rose was appointed by President Joe Biden and sworn in on July 12, 2021. At OVC, she oversees nearly \$9 billion in grant funding to provide vital compensation and assistance to persons impacted by crime. Prior to her OVC appointment, Ms. Rose was selected to serve on the Department of Defense Independent Review Commission on Sexual Assault in the Military, where she led the Victim Care and Support line of effort.

Ms. Rose spent nearly 20 years at DOJ serving in numerous roles including as Deputy Director at OVC, as Acting Director and Deputy Director for the National Institute of Justice, and as the Chief of Staff for the Office on Violence Against Women. In 2016, Ms. Rose had the distinct privilege of working at the White House on detail as a Senior Policy Advisor on violence against women in the Office of Vice President Joe Biden. As Senior Policy Advisor, she provided expert advice and guidance on domestic violence, sexual assault, and stalking. In 2013, Ms. Rose spent 8 months as a victim advocate in the U.S. Attorney's Office in Washington, D.C., working hands-on with victims of all violent crimes. At DOJ, Ms. Rose spearheaded many large-scale Federal projects including the first national survey to measure the crime of stalking in the United States; an action research project on untested sexual assault kits that produced national models for jurisdictions around the country; and a virtual training on sexual assault forensic exams with Dartmouth Medical School. Ms. Rose also led the development of the first National Sexual Assault TeleNursing Center, which provides virtual guidance to medical personnel conducting sexual assault forensic exams in rural and isolated areas. In between her periods of Federal service, Ms. Rose served in the non-profit sector as the Director of Strategic Partnerships for Healing Justice and as the Executive Director for End Violence Against Women International. She holds an M.S. in criminal justice from Northeastern University and a B.A. in sociology from George Mason University.

Jenefer Duane *Senior Program Analyst, Office for Older Americans, Consumer Financial Protection Bureau*

Jenefer Duane is the Senior Program Analyst in Consumer Financial Protection Bureaus' Office for Older Americans. In 2013 she led the development of the Bureau's Money Smart for Older Adults program for 10 years, and currently leads the Elder Fraud Prevention and Response Network program and its pilot Elder Financial Exploitation SAR Review Team Initiative.

Jenefer's 25-year elder justice career was launched in the mid 1990s when she led a group of community stakeholders, including 15 financial institutions, to establish the Marin Bank Reporting Project. She then founded and led the non-profit Elder Financial Protection Network in California for 10 years prior to her joining the CFPB in 2011.

She has received numerous awards for her contributions to the field of elder justice including: the Outstanding Service in Elder Abuse Prevention Award from the California Attorney General, and the Beacon Award from the California Credit Union League. In 2009 she was presented with the FDIC's 75th Anniversary Chairman's Award for Excellence and Innovation in Financial Education and the Illinois Department of Aging and the Department of Financial and Professional Regulation jointly recognized her contributions for the establishment of the Illinois Financial Abuse Specialist Team.



Debbie Feinstein *Chief, Special Victims Unit, Montgomery County's State's Attorney's Office*

Debbie Feinstein has been Assistant State's Attorney in Montgomery County, Maryland for the past 23 years. In 2012, she became the Chief of the Special Victims' Division where she is responsible for supervising and prosecuting cases involving homicide, child abuse and exploitation, domestic violence, human trafficking, elder abuse, and sexual assault. In 2015, she also became the Co-Chief of the newly formed Crimes Against Seniors and Vulnerable Adults Unit. Ms. Feinstein currently chairs the Montgomery County Domestic Violence Coordinating Council's Education and Outreach Committee, the Montgomery County Domestic Violence Fatality Review Team, and the Montgomery County Elder/Vulnerable Adult Abuse Task Force. She is a member of other collaborative multidisciplinary teams, including the Montgomery County Sexual Assault Response Team and the Tree House Child Advocacy Center. Ms. Feinstein also chairs the special victims' prosecution and prevention subcommittee for the Maryland State's Attorneys' Association and is a member of the Governor's Family Violence Council. Ms. Feinstein has worked on multiple successful statewide legislative efforts, including a law that delineates nonfatal strangulation as a felony in Maryland. She has presented on her areas of specialty at international, national, and local trainings, including for prosecutors in Vietnam and Colombia, for the National District Attorney's Association, and the Maryland Coalition Against Sexual Assault. Ms. Feinstein is also an adjunct professor at the Washington College of Law at American University.

Amy L. Friedman, Esq. *Assistant Director, Division of Enforcement, United States Securities & Exchange Commission*

Amy Friedman is an Assistant Director in the Securities & Exchange Commission's Division of Enforcement. In that role, held since 2013, she oversees investigations regarding various types of securities violations including offering and accounting frauds, auditor independence, investment adviser conflicts of interest, ICOs, and insider trading. Prior to joining the SEC in 2004, Ms. Friedman was an associate in the Washington, D.C. office of O'Melveny & Myers LLP where she represented companies and individuals in regulatory investigations. Prior to attending law school, Ms. Friedman worked as a paralegal and served as the Elder Abuse Coordinator at the New York County District Attorney's Office, where she assisted in investigations involving exploitation of seniors. Ms. Friedman received a B.A. in Sociology with distinction from Yale University and her J.D. magna cum laude from American University's Washington College of Law.



Richard Goldberg *Deputy Director, Consumer Protection Branch, U.S. DOJ*

Rich Goldberg is a Deputy Director of the U.S. Department of Justice, Consumer Protection Branch, where he oversees the Branch's consumer fraud and privacy portfolio. Since 1999, he has brought and supervised criminal and civil cases relating to fraudulent telemarketing schemes, internet deception, mass-mailing fraud, unauthorized account charges, and other offenses. He helps coordinate the Department's Transnational Elder Fraud Strike Force and serves as a co-chair of the Global Antifraud Enforcement Network, which consists of government authorities from across the globe dedicated to halting large-scale international fraud schemes.



Jacque Gray, PhD, LPC *Consultant, Norman, OK*

Dr. Jacque Gray is a Choctaw/Cherokee retired associate professor with the Center for Rural Health (CRH) at the University of North Dakota (UND) School of Medicine & Health Sciences. She also serves as director of the National Indigenous Elder Justice Initiative (NIEJI), a national resource center to address elder abuse in Indian Country. In addition, Gray is the lead for the Strong Heart Study Psychosocial Work Group, a longitudinal study of cardiovascular disease and metabolic disorders in American Indians that began in 1988. Gray also consults with the National Center for Native Behavioral Health at the University of Iowa. She has worked to address health, mental health, and health disparities across Indian Country for 40 years and internationally, working with Māori suicide prevention. She participated in the White House Conference on Aging in 2015 to address elder justice issues. Gray received a doctorate from Oklahoma State University in 1998 and has been at UND since 1999. Gray is a member of the Society of Indian Psychologists; she is a fellow of the American Psychological Association.

Detective Cherie Hill *Family Protection Detail, Anaheim Police Department*

Detective Cherie Hill is a nationally recognized law enforcement expert in the field of elder and dependent adult abuse and neglect. She has an extensive and successful history of developing training programs in elder abuse, bringing together collaborators from community organizations, including Adult Protective Services, physicians and law enforcement. As a Detective in the Family Protection Detail in the Anaheim Police Department from 2005-2017, she recognized the need for law enforcement to develop the skills and knowledge needed to investigate elder and dependent adult crimes, including death investigations. From 2017-2023, Detective Hill served as a patrol officer and supported first responder, on-site elder abuse calls. Currently, she has returned to the Family Protection Detail to continue the development of training and investigations of elder and dependent abuse. She has been an invited speaker to numerous national and regional convenings, and has served on several U.S. Department of Justice committees.



Officer Ronald M. Johnson *Baltimore County Police Department*

Officer Johnson has been a member of the Baltimore County Police Department for 17 years. He has been in his current leadership role as the Elder/Vulnerable Adult Abuse and Neglect Liaison for the department for almost three years. Prior to that he was a patrol officer in the Pikesville Precinct for approximately 14 years. Some of his current duties include: training new recruits on elder abuse and neglect issues at the Police Academy, reviewing all Elder/Vulnerable Adult Abuse and Neglect Reports for his jurisdiction, fostering relationships with representatives from the Attorney General's Office, Department of Aging and Adult Protective Services. Officer Johnson also gives safety briefings and presentations to Senior Centers and Senior Co-Op buildings to ensure that individuals have the tools and knowledge to keep themselves safe.



Beverly Laubert *National Ombudsman Program Coordinator, U.S. DHHS*

Beverly Laubert is the National Ombudsman Program Coordinator at the federal Administration for Community Living. She served as an Ombudsman in Ohio for 33 years, including 26 as the State Long-Term Care Ombudsman. She spent a year in the Governor's Cabinet as the Director of the Ohio Department of Aging. She holds a Bachelor of Arts in Gerontology from Kent State University and a Master of Arts from The Ohio State University's John Glenn College of Public Affairs, with an emphasis in strategic leadership and long-term care. She brings to her work a devotion to public policy that supports person-centered, excellent care and services.

Susan Lynch, JD, DrPH *Senior Counsel for Elder Justice, Civil Division, Fraud Section, U.S. DOJ*

Susan C. Lynch, JD, DrPH, is Senior Counsel for Elder Justice at the United States Department of Justice where she leads the Department's National Nursing Home Initiative. Dr. Lynch has been prosecuting healthcare fraud with the Department for 24 years and is the Department's subject matter expert on skilled nursing facilities and home health agencies. She was responsible for bringing one of the Department's first failure of care cases against a national skilled nursing home chain. Dr. Lynch was awarded a Doctor of Public Health in Health Management and Leadership from the Johns Hopkins Bloomberg School of Public Health, and has received the Gerontology Certificate designation. Dr. Lynch was inducted into the Delta Omega Public Health Honor Society at Hopkins. Dr. Lynch is frequently invited to speak on nursing home and elder justice issues, and recently presented at the National Medicaid Fraud Control Unit Annual Conference, the National Consumer Voice Annual Conference, and the Health Care Compliance Association Annual Meeting.

Dr. Lynch has served as an Adjunct Professor at the George Washington University Law School since the fall of 2000. She received her BA from Dartmouth College, her JD from the Indiana University Maurer School of Law, and her LLM (Masters of Law in Advocacy) with Distinction from the Georgetown University Law Center. Dr. Lynch is a national registry paramedic, NRP, and volunteers with the Pleasant Valley Volunteer Fire Department in Maryland.



Andy Mao *National Elder Justice Coordinator, Deputy Director, Civil Fraud Section, U.S. DOJ*

Andy Mao is the Department of Justice's National Elder Justice Coordinator, as well as a Deputy Director in the Civil Fraud Section of the Commercial Litigation Branch. As the Department's Elder Justice Coordinator, Mr. Mao leads the Elder Justice Initiative and helps to support and coordinate the Department's law enforcement and programmatic efforts to combat elder abuse, neglect and financial exploitation.

In his work in the Fraud Section, Mr. Mao focuses primarily on health care fraud matters and has litigated matters in the hospital, pharmaceutical, and nursing home contexts. He joined the Department in 2000 after completing his federal clerkship in the District of New Jersey. Mr. Mao is a graduate of Cornell University and the University of Virginia School of Law.

Julia K. McGlamary *Supervisor, Montgomery County Adult Protective Services*
Julia McGlamary is a licensed clinical social worker and a board-certified supervisor in the State of Maryland, with 18 years of experience working with older and vulnerable adults as a supervisor, investigator, geriatric case manager, psychotherapist, and researcher. She is currently a supervisor with Adult Protective Services Investigations of Montgomery County, Maryland. She provides clinical supervision to a team of social work investigators, is a liaison with community partners, and provides clinical training to adult services staff, partners, and the community. Ms. McGlamary is a member of the Montgomery County Elder and Vulnerable Adult Abuse Task Force, the Montgomery County World Elder Abuse Awareness Day Planning Committee, the National Adult Protective Services Association Public Policy Committee, and the Gaithersburg Hoarding Task Force. Ms. McGlamary holds a Bachelor of Arts in Psychology from Washington University in St. Louis and a Master's in Social Work from the University of Maryland School of Social Work. She is a recipient of the University of Maryland School of Social Work Innovation in Social Work Alumni Award for 2021.



Christopher J. Merkle *Senior Investigator, Boulder County District Attorney's Office, 20th Judicial District of Colorado*

Chris Merkle was born and raised in rural South Dakota and moved to Colorado in 1985. He received his college degree in Criminal Justice, which launched his career in law enforcement and public service. He served the community of Longmont for 25 years working as a patrol officer, a traffic officer, a training officer and as a detective. In 2020, Chris retired from the Longmont Police Department and now works as a Senior Investigator for the Boulder County District Attorney's Office, in the 20th Judicial District.

In 2009, while working for the Longmont Police Department, Chris attended a weeklong "training of trainers" course sponsored by the Federal Law Enforcement Training Center (FLETC). This training focused on effective investigative strategies for crimes against elderly victims. Attending this course sparked a passion for him, and he soon became a prominent trainer in the Boulder County law enforcement community on elder abuse investigations.

In 2017, Chris became a national trainer for elder abuse investigations. He continues to work as a consultant for the National Clearinghouse on Abuse in Later Life (NCALL). He is a part of a multidisciplinary training team, consisting of prosecutors, adult protective service caseworkers, and victim advocates. He has traveled around the United States training police officers and detectives on the dynamics of elder abuse and effective investigative strategies to examine these cases. Chris has assisted in developing curriculums, training videos, and online courses for both patrol officers and detectives on elder abuse investigations. He has presented at conferences across the United States, such as the Ending Violence Against Women International (EVAWI) and on various webinars on the topic of victim centered investigations and elder justice.

In his current role as a Senior Investigator for the Boulder County District Attorney's Office, Chris remains an active member of several multidisciplinary teams that advocate for the elder community. Chris is dedicated to serving elder victims and remains passionate about these types of cases.

Laura Mosqueda, MD, FAAFP, AGSF *Professor of Family Medicine and Geriatrics, Keck School of Medicine, USC*

Laura Mosqueda, MD, is a professor of Family Medicine and Geriatrics at the Keck School of Medicine of the University of Southern California and Director of the National Center on Elder Abuse. She studies the causes, consequences, and prevention of elder abuse, particularly among people with dementia. Dr. Mosqueda's work is done in a variety of places, from the laboratory to the classroom to the field. She serves as a consultant and expert witness for colleagues in law enforcement and is a standing member of the Los Angeles County Elder Abuse Forensic Center, a multidisciplinary team that directly serves older adults who may be victims of abuse or neglect.



Captain Nicole Nappi *EMS, Training & Education, Baltimore County Fire Department*

Captain Nicole Nappi began her EMS career shortly after graduation from Mt Hope High School in Rhode Island when she obtained her EMT certification. In 1997, she moved her practice to Baltimore, Maryland, after successfully obtaining her Paramedic qualification. In 2003, Captain Nappi joined the Baltimore County Fire Department and continued to promote within her field. In 2010, she became an Instructor for the Baltimore County Fire Academy, providing guidance and instruction to two entry level recruit classes. In addition to her instructor position at the Fire Academy, Nicole also became an Instructor at Carroll Community College and with the Maryland Fire Rescue Institute, teaching EMS courses from 2014-present. Nicole was promoted to EMS Lieutenant in 2016, and to EMS Captain in 2023, where she oversees EMS training for Baltimore County. Captain Nappi holds a seat on various EMS committees, to include EMS Deployment, Research and Development, Instructor and Training committees, Significant Events and Review Committee, and Community Risk Reduction. She has been awarded numerous Unit Citations and has committed herself to training Fire Department Personnel and the surrounding community. Dr. Stacy Phillips develops and deploys effective solutions to challenging and systemic crime victimization issues as a Victim Justice Program Specialist with the Office for Victims of Crime (OVC) at the U.S. DOJ. Leveraging more than 20 years of experience in the victim services field, she works collaboratively across OVC's Discretionary and Human Trafficking Teams to create, implement, and monitor a broad range of programs with national reach. She has spearheaded initiatives on polyvictimization, reducing child fatalities and serious injuries, law enforcement and the community, and currently leads OVC's opioid/ drug addiction crisis initiative. Stacy represents OVC on the DOJ Prison Rape Elimination Act Working Group, the Federal Inter-Agency Work Group on Child Abuse and Neglect, and the White House School Safety Inter-Agency Policy Committee. Stacy spent 15 years working with children and families in the public child welfare systems of Connecticut, Texas, and Washington D.C. In D.C., she served on the Children's Justice Act Task Force, assisted in developing the District's Human Trafficking Task Force and started D.C.'s Parent Advisory Council. Patricia Poss is an attorney in the Federal Trade Commission's Bureau of Consumer Protection. She currently works on the FTC's [ReportFraud.ftc.gov](https://www.ftc.gov/report-fraud) and [IdentityTheft.gov](https://www.ftc.gov/identity-theft) websites, which collect millions of reports each year about identity theft, fraud, scams, and bad business practices.

Ms. Poss heads the FTC's Senior Fraud Advisory Office, housed in the Division of Consumer Response and Operations. As part of this role, she works on the agency's initiatives to serve older consumers and co-leads the Scams Against Older Adults Advisory Group's Scam Prevention Research Committee. Ms. Poss also works to combat fraud in lower-income and underserved communities, serving on the agency's Legal Services Collaboration and its Every Community Initiative. Ms. Poss has previously served as Chief of BCP's Mobile Technology Unit and counsel to the Director of the Bureau. She also spent several years investigating and litigating consumer protection cases that involved Internet fraud (including phishing), spam, and telemarketing fraud. Detective Jeff Prater *Colleyville Police Department, Special Investigations Unit, Member of the Secret Service Financial Crimes Task Force*

Jeff Prater is a Detective with the Colleyville Police Department's Special Investigations Unit and is currently assigned to the United States Secret Service Cyber Crimes Task Force. In his over 20-year career, Detective Prater has worked in a number of capacities including: SWAT, Criminal Interdiction Officer, Undercover Operations, Federal Task Force Officer, TCOLE Instructor, Police Explorer Advisor, and Citizens Police Academy Coordinator.

As a member of both Colleyville's Police Department's Special Investigations Unit and United States Secret Service Task Force, Detective Prater investigates high profile, complex and sophisticated criminal cases such as: Conspiracy, Organized Crime, Human & Sex Trafficking, Money Laundering, Elder Fraud, BECs, Bank & Wire Fraud, Identity Theft and much more. Justin Ramsdell, Psy.D. *Associate Professor of Psychology, George Mason University*
Dr. Ramsdell is a psychologist and Associate Professor of Psychology at George Mason University in Fairfax, Virginia, whose teaching and research focuses on forensic psychology. Specifically, his work focuses on law enforcement interactions with victims of crime and/or individuals diagnosed with severe mental illnesses, the psychological experience of crime victims, and psychological factors influencing aggressive behavior. Aside from teaching psychology at the undergraduate level he also serves as a Crisis Intervention Team (CIT) trainer conducting regular trainings on crisis de-escalation and law enforcement interactions with individuals diagnosed with severe mental illness. Additionally, he currently works as an expert witness/consultant in legal cases involving the interactions of law enforcement/correctional personnel with individuals with mental illness and/or victims of crime amongst other topics.



Captain Jordan Satinsky *Montgomery County Police Department*
Captain Jordan Satinsky started in law enforcement in 1999. Presently, Captain Satinsky is the Director of the Montgomery County Police Department's Community Engagement Division (CED). The CED is comprised of the School Resource Officer Unit, Crisis Intervention Team, Behavioral Assessment Unit, Honor Guard Unit, the Peer Support Team, and the Chaplaincy Unit. Since becoming the Director, Captain Satinsky has instituted a real-time Crisis Intervention Team and created the Behavioral Assessment Unit. He is currently collaborating with the various agencies on the creation of a county-level Public Safety Wellness Center.

Over the course of his career, Captain Satinsky has worked as a homicide investigator, adult sex crimes investigator, child sexual/physical abuse investigator, a district investigator, and was a member of a federal task force. Captain Satinsky has served as the creator and supervisor of the Sexual Assault Unit. He also was responsible for re-developing the Domestic Violence Unit and the Elder/Vulnerable Adult Unit of the Montgomery County Police Department.
