

- Provide funding for client services, including a full-time advocate and clinical experts
- Ensure access to field-based psychological and decision-making capacity assessments
- Include law enforcement for guidance on the criminal aspects of the case

- Establish clear, tangible, and achievable goals within the MDT to ensure success and progress
- Network to recruit relevant agencies to serve on the MDT
