

Amendment 1 to Appendix D of Corrected Consent Decree, Docket No. 19-1 Settling Cash Defendants

No later than thirty (30) days after the Effective Date of Amendment 1 to Appendix D, the Settling Cash Defendants listed above shall pay, in accordance with Paragraph 27.a, the total sum of \$12,625,000 (TWELVE MILLION SIX HUNDRED TWENTY-FIVE THOUSAND DOLLARS) to OPOG, to be deposited into one or more Qualified Settlement Funds as provided for in that Paragraph.

The following additional parties associated with facility 1 are added to Appendix D as SETTLING CASH DEFENDANTS. These are parties that had previously resolved their liability associated with facility 1 to Settling Work Defendant OPOG, and are being added to acknowledge that the United States intends contribution protection for those parties regarding their liability associated with facility 1, as provided for in Paragraph 81.
