PLAINTIFF'S NOTICE OF LODGING PROPOSED CONSENT DECREE

Plaintiff United States of America hereby notifies the Court of the lodging of the attached proposed Consent Decree executed with Defendant Brenda Massey. The Court is requested to withhold consideration of the Consent Decree while the United States provides an opportunity for public comment pursuant to 28 C.F.R. § 50.7. The Department of Justice will publish in the Federal Register a notice that the proposed Consent Decree has been lodged with the Court. The notice will solicit public comment for a period of 30 days. No action is necessary by the Court during the public comment period.

After the close of the comment period, the United States will evaluate any comments received. The United States will then promptly advise the Court in a subsequent filing whether the United States believes that it is appropriate to proceed with the settlement and would request that the Consent Decree be entered at that time.
