## NOTICE: NO CASE CURRENTLY PENDING BEFORE THE EXECUTIVE OFFICE FOR IMMIGRATION REVIEW

You are receiving this notice because you appeared at the immigration court on the date and time provided on the Notice to Appear (NTA), which you received from the Department of Homeland Security (DHS). At this time, the immigration court has not received a copy of your NTA from DHS and no hearing is scheduled for you. DHS is required to file your NTA with the immigration court to initiate removal proceedings. Because DHS has not filed your NTA, you currently do not have a case pending before any immigration court.

Only DHS has the legal authority to file an NTA and initiate removal proceedings. You may not file your own NTA. The immigration court also cannot accept any other filings from an individual who does not have a pending case at the court.

Currently, you are not scheduled for any future hearings at any immigration court. However, DHS may serve you with a new NTA. If you receive a new NTA from DHS or receive a Notice of Hearing from the immigration court, you will be required to appear for the scheduled hearing.
