**ORDER GRANTING JOINT CONSENT TO ENTER  
SETTLEMENT OFFICER PROGRAM & JOINT MOTION TO STAY DEADLINES**

On March 13, 2025, the parties filed a Joint Consent to Enter Settlement Officer Program and Joint Motion to Stay Deadlines. Through the filing, the parties request a referral to OCAHO's Settlement Officer Program and a stay of all case deadlines.<sup>1</sup> The Court finds referral of this case to the Settlement Officer Program appropriate. The Court therefore ORDERS that the matter be referred to the Settlement Officer Program for a period of 60 days, beginning on April 21, 2025, and continuing through May 20, 2025.

The Court designates the Honorable Jean C. King as the Settlement Officer for this case. Should the parties reach a settlement, they shall inform the undersigned of such settlement and provide the appropriate filing. *See* 28 C.F.R. § 68.14.<sup>2</sup>

**AMENDED<sup>4</sup> ORDER GRANTING JOINT CONSENT TO ENTER  
SETTLEMENT OFFICER PROGRAM & JOINT MOTION TO STAY DEADLINES**

On March 13, 2025, the parties filed a Joint Consent to Enter Settlement Officer Program and Joint Motion to Stay Deadlines. Through the filing, the parties request a referral to OCAHO's Settlement Officer Program and a stay of all case deadlines.<sup>5</sup> The Court finds referral of this case to the Settlement Officer Program appropriate.
