ORDER REJECTING COMPLAINANT’S FILINGS IN RESPONSE TO THE COURT’S
CASE MANAGEMENT ORDER

This case arises under the employment discrimination provisions of the Immigration and Nationality Act (INA), as amended, 8 U.S.C. § 1324b.

On October 17, 2023, Complainant, Zaji Obatala Zajradhara, filed a complaint with the Office of the Chief Administrative Officer (OCAHO), alleging Respondent discriminated against him and retaliated against him in violation of 8 U.S.C. § 1324b(a)(1) and (a)(5).

On May 13, 2025, the Court issued a Case Management Order (Accepting Answer, Deferring Summary Decision Motion, Converting to Electronic Filing, Case Schedule).

Also on May 13, 2025, Complainant submitted a filing labeled a “Response to the Court’s Order.”

On May 14, 2025, Complainant submitted a filing labeled a “Motion of Errata Regarding Prior Submission” referring to material included in the “Response to the Court’s Order.”

On May 17, 2025, Complainant submitted a filing labeled “Addendum Response to Court’s Order.”

The Court’s May 13, 2025 Case Management Order did not require a response from either party.

Complainant's "Response to the Court's Order" also does not make a "request . . . for some action by an Administrative Law Judge," so it is also not a motion. 28 C.F.R. § 68.2.¹

Because it was not required, and it is not a motion, the Complainant's filing and addenda (all three filings) will not be considered.

The case schedule set in the Case Management Order controls.
