Executive Office for Immigration Review Swears in 31 Immigration Judges

FALLS CHURCH, VA – The Executive Office for Immigration Review today announced the investiture of 31 new immigration judges. Deputy Attorney Rod. J. Rosenstein delivered the opening remarks and Principal Deputy Chief Immigration Judge Christopher A.
