1. **Indicate Whether an Uploaded Motion Is an Unopposed Motion or Joint Motion**
When filing a document, if the Motion Document Category selected, then two new fields appear allowing the user to indicate whether the motion is an Unopposed Motion or a Joint Motion. This new feature will allow the uploader to provide this information to the court when filing a motion.
