PROPOSED DECISION

Claimant, SUZANNE R. MATTHEWS, EXECUTRIX OF THE ESTATE OF ORUS J.
MATTHEWS, DECEASED, who owned 33 shares of stock in the Cia. Antillana de
Acero, S.A. (Antillian Steel Corporation), asserts a claim under Title V of
the International Claims Settlement Act of 1949, as amended, against the
Government of Cuba because of its nationalization of said Corporation.

In our decision, entitled the <u>Claim of Independence Foundation</u> (Claim No. CU-2152), which we incorporate herein by reference, we held that the Cia. Antillana de Acero, S.A. was intervened by the Government of Cuba on March 25, 1960 under Resolution No. 1 of the Cuban Ministry of Finance; and that this type of claim is within the purview of Section 503(a) of the Act under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value of \$100.00 per share of stock.

On the basis of evidence of record in the instant case, the Commission finds that the claimant, SUZANNE R. MATTHEWS, EXECUTRIX OF THE ESTATE OF ORUS J. MATTHEWS, DECEASED, comes within the terms of the <u>Independence</u>

Foundation decision; that the late ORUS J. MATTHEWS and all beneficiaries of his estate were nationals of the United States at all times relevant to this claim; that the late ORUS J. MATTHEWS had been the owner of 33 shares of stock in the Cia. Antillana de Acero, S.A. since prior to March 25, 1960;

and that he suffered a loss in the total amount of \$3,300.00 within the meaning of Title V of the Act. Further, the Commission finds that the amount of loss sustained shall be increased by interest thereon at the rate of 6% per annum from March 25, 1960, the date the claim arose, to the date on which provisions are made for the settlement thereof. (See <u>Independence Foundation</u>, supra.)

CERTIFICATION OF LOSS

The Commission certifies that SUZANNE R. MATTHEWS, EXECUTRIX OF THE ESTATE OF ORUS J. MATTHEWS, DECEASED, suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of Three Thousand Three Hundred Dollars (\$3,300.00) with interest at 6% per annum from March 25, 1960 to the date of settlement.

NOTICE TO TREASURY: The above-referenced securities may not have been submitted to the Commission or if submitted, may have been returned; accordingly, no payment should be made until claimant establishes retention of the securities or the loss here certified.

Section 501 of the statute specifically precludes any authorization for appropriations for ayment of these claims. The Commission is required to certify its indings to the Secretary of State for possible use in future negotiations with the Government of Cuba.
