PROPOSED DECISION

Claimant, WADE C. POFFENBERGER, asserts a claim against the Government of Cuba under Title V of the International Claims Settlement Act of 1949, as amended, based upon a stock interest in the Cia. Azucarera Vertientes-Camaguey de Cuba.

In our decision entitled the <u>Claim of Ruth Anna Haskew</u> (Claim No. CU-0849 which we incorporate herein by reference), we held that the properties owned by the Company were nationalized or otherwise taken by the Government of Cuba on August 6, 1960, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value per share of \$46.3946.

On the basis of evidence in the record in the instant case, the Commission finds that this claimant comes within the terms of the <u>Haskew</u> decision; that he and Mable L. Poffenberger, now deceased, were American nationals at all requisite times; that they were the joint owners of four shares of stock in the Cia. Azucarera Vertientes-Camaguey de Cuba from prior to August 6, 1960 until the death of Mable L. Poffenberger on January 1, 1963; that claimant became the sole owner of the four shares at that time; and that he succeeded to and suffered a loss in the amount of \$185.58 with respect to such shares within the meaning of Title V of the Act. Further, the Commission

finds that the amount of loss sustained shall be increased by interest thereon at the rate of 6% per annum from August 6, 1960, the date of loss, to the date on which provisions are made for the settlement thereof. (See Haskew, supra.)

CERTIFICATION OF LOSS

The Commission certifies that WADE C. POFFENBERGER succeeded to and suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of One Hundred Eighty-five Dollars Fifty-eight Cents (\$185.58) with interest at 6% per annum from August 6, 1960 to the date of settlement.

NOTICE TO TREASURY: The above-referenced securities may not have been submitted to the Commission or if submitted, may have been returned; accordingly, no payment should be made until claimant establishes retention of the securities for the loss here certified.

The Commission is required to certify its findings to the Secretary of State for possible use in future negotiations with the Government of Cuba.
