PROPOSED DECISION

INNOCENT JAMES VOLPE, who owned a stock interest in the Cia. Azucarera Vertientes-Camaguey de Cuba, asserted a claim under Title V of the International Claims Settlement Act of 1949, as amended, against the Government of Cuba because of its nationalization of said Company. Said INNOCENT JAMES VOLPE a United States national having died and Letters Testamentary having been issued to ROBERT J. VOLPE, he is substituted as claimant herein.

In our decision entitled the Claim of Ruth Anna Haskew (Claim No. CU-0849 which we incorporate herein by reference), we held that the properties owned by the Company were nationalized or otherwise taken by the Government of Cuba on August 6, 1960, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value per share of \$46.3946.

On the basis of evidence in the record in the instant case, the Commission finds that this decedent came within the terms of the Haskew decision; that he was an American national at the requisite times; that he was the owner of 142 shares of stock in the Cia. Azucarera Vertientes-Camaguey de Cuba since prior to August 6, 1960; and that he suffered a loss in the amount of \$6,588.03 within the meaning of Title V of the Act. Further, the Commission finds that

the amount of loss sustained shall be increased by interest thereon at the rate of 6% per annum from August 6, 1960, the date of loss, to the date on which provisions are made for the settlement thereof. (See Haskew, supra.)

CERTIFICATION OF LOSS

The Commission certifies that ROBERT J. VOLPE, EXECUTOR OF THE ESTATE OF INNOCENT JAMES VOLPE, DECEASED, succeeded to and suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of Six Thousand Five Hundred Eighty-eight Dollars Three Cents (\$6,588.03) with interest at 6% per annum from August 6, 1960 to the date of settlement.
