PROPOSED DECISION

Claimant, BRADLEY HALL, who owned a bond issued by Cuba Northern Railways Company, asserts a claim under Title V of the International Claims Settlement Act of 1949, as amended, against the Government of Cuba because of its nationalization of said Company.

In our decision entitled the Claim of Kentucky Home Mutual Life Insurance Company (Claim No. CU-1339 which we incorporate herein by reference), we held that the properties of the Railway were nationalized or otherwise taken by the Government of Cuba on October 13, 1960, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value per \$500 bond of \$341.28 including interest to October 13, 1960.

On the basis of evidence in the record in the instant case, the Commission finds that this claimant comes within the terms of the Kentucky decision; that he was an American national at the requisite times; that he has been the owner of one \$500 bond issued by Cuba Northern Railways Company since prior to October 13, 1960; and that he suffered a loss in the amount of \$341.28 within the meaning of Title V of the Act. Further, the Commission finds that the amount of loss sustained shall be increased by interest thereon at the rate of 6% per annum from October 13, 1960, the date of loss, to the date on which provisions are made for the settlement thereof. (See Kentucky, supra.)

CERTIFICATION OF LOSS

The Commission certifies that BRADLEY HALL suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of Three Hundred Forty-one Dollars and Twenty-eight Cents (\$341.28) with interest at 6% per annum from October 13, 1960 to the date of settlement.

The Commission is required to certify its findings to the Secretary of State for possible use in future negotiations with the Government of Cuba.
