PROPOSED DECISION

Claimant, MICHELINA LA CARRUBBA, who owned a stock interest in the Cia. Azucarera Vertientes-Camaguey de Cúba, asserts a claim in the amount of \$2575.82 under Title V of the International Claims Settlement Act of 1949, as amended, against the Government of Cuba because of its nationalization of said Company.

In our decision entitled the <u>Claim of Ruth Anna Haskew</u> (Claim No. CU-0849 which we incorporate herein by reference), we held that the properties owned by the Company were nationalized or otherwise taken by the Government of Cuba on August 6, 1960, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not agaim detail here the reasons or the method used in determining the value per share of \$46.3946.

On the basis of evidence in the record in the instant case, the Commission finds that this claimant comes within the terms of the <u>Haskew</u> decision; that she was an American national at the requisite times; that she and her husband, a United States national, had been the owners of 102 shares of stock in the Cia. Azucarera Vertientes-Camaguey de Cuba since prior to August 6, 1960; and that they suffered a loss in the amount of \$4732.25 within the meaning of Title V of the Act. Upon the death of Emanuel La Carrubba in 1968, claimant became the sole owner of the claim. Further, the Commission finds that the amount of loss sustained shall be increased by interest thereon at the rate of 6% per annum from August 6, 1960, the date of loss, to the date on which provisions are made for the settlement thereof. (See <u>Haskew</u>, <u>supra</u>.)

It will be noted that the total amount of loss found herein is in excess of the amount asserted by claimant. However, in determining the amount of loss sustained, the Commission is not bound by any lesser or greater amounts which may be asserted by claimant as the extent thereof.

CERTIFICATION OF LOSS

The Commission certifies that MICHELINA LA CARRUBBA suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of Four Thousand Seven Hundred Thirty-Two Dollars and Twenty-Five cents

(\$4732.25) with interest at 6% per annum from August 6, 1960 to the date of settlement.
